Zayo has been experiencing issues with getting our EA FONSI. Zayo submitted our draft EA on time, but has run into delays getting SHPO approval on the underground segments of our routes. Our EA subcontractor has had to bring in an Archeologist to confirm that our route is following pre-disturbed ground only.

Zayo had to request an EA extension in January which BTOP approved.

Because of the delay in getting our FONSI, Zayo has had to revise our 9 month budget to include money to start engineering. Sent out Engineering Request For Proposal (FRP) to 19 vendors. Zayo received bids and went through our competitive bid process. The Engineering was awarded to Fiber Engineering and Design. Fiber Engineering and Design had the lowest price. They did not receive points for being a local company, but they did receive points for being a small business. Fiber Engineering and Design is a New Jersey company, but they have committed to hiring local employees to supplement their staff. To date, they have hired three employees from Minnesota.

Sent out RFP for Inside Plant Engineering and Design. Received bids back at the end of the quarter. Zayo will do source selection and award at the beginning of next quarter.

Sent out Materials RFP. Zayo has received bids as of the end of the quarter. Zayo will make this award at the beginning of next quarter after doing our source selection process.
