Staff working on grant are all performing such work in addition to regularly assigned duties causing delays in some paperwork. Understanding all federal grant processes for administration of grant has been a challenge. The timing of State elections and subsequent outcome resulted in loss of key administrative grant staff (Secretary and PI) by the end of December; no appointments were made. Review of sites and subsequent discussions with radio staff resulted amendment of Environmental SAC, effective in December. Such change requires a request to NTIA to delay environmental report submission. DoIT will need help from BTOP to facilitate completion of EAs. EA coordinator will work with Grant officers and DoIT staff to move forward.
