### 1. Please describe significant project accomplishments completed during this quarter (600 words or less).

We completed the fiber route path maps for the Cultural Survey. The certified cultural survey specialist was hired and the survey began before the end of the quarter. Tribal monitors for the survey work were also hired. The attorneys for the tribe have made progress with the tribe's fiber contracts. The telecommunications company agreed to honor the prior commitment by the company that installed the fiber across tribal land to provide the two strands and possibly increase it to four for maintenance purposes. They've also agreed in principle to extend the original agreement so that we can meet the 20 year requirements for fiber contracts. This should increase the value of the tribe's inkind match once we have this contract finalized and appraised. We met with the Nevada Department of Transportation to review the portions of the route that are on highway right of way. Initial response is that portion of our route should get approval provided the proper detailed design requirements are followed in the application

We are advancing work on the tribal and highway right of ways and easments, accelerating the contractor's work on network design prior to the overall contract completion, and hiring a project manager to assist with the multi-tasking for this project.
2b.	Environmental Assessment	80	Delays caused by the state historical preservation office's requirement for a complete cultural survey have prevented us from completing the environmental assessment as projected in the baseline. We are accelerating the preliminary report through the SHPO and NTIA to speed up the process.
2c.	Network Design	50	final detailed network design depends upon the cultural survey having no significant findings. At the time of this report, that survey hadn't progressed enough for us to begin the final detailed design. We do have the fiber route maps completed. We have asked the primary contractor to begin work on the final designs in advance of the overall construction contract being completed.

Rights of Way	20	Because we haven't been able to complete the survey so as to know the fiber route will make it through the environmental assessment, final detailed designs of the route haven't been completed. These are necessary for the application process for rights of way on the highway. Rights of way approvals on tribal properties can't begin until we know the route will not have any significant findings from the cultural survey. Indications are that the projected fiber route will stand so we are speeding up the process of getting clearance on all right of ways and easements through the realty department.

The cultural survey process required by state historical preservation office is extensive and covers 44 miles of tribal land. Because the fiber route involves an old railroad bed, we had some issues in convincing them that it doesn't qualify for the federal registry due to prior modified use. This would have required an environmental impact statement on that portion of the route and would have effectively required re-routing of the fiber due to the lengthy process and costs associated with that process. The tribe is requiring additional monitoring of this process for cultural discoveries to address potential impacts to the Native American Graves Protection and Repatriation Act.

As a partial result of these additional costs and time delays, we have had to put the hiring of a project manager on hold until a modification of the six-month budget can be completed.

Another difficulty we've encountered, is the lengthy process in formalizing the tribe's access to its fiber rights on existing cable into Reno. The attorneys have made significant process, but we've incurred delays because one of the attorneys always has prior commitments. In addition, the NTIA's requirements for these indefeasible rights of use are complicating the contract.

The six month budget mod needs to be approved so we have to overcome the delay in hiring the project manager. The challenge will be in getting this position filled soon enough before the end of the quarter so that they can have a significant impact on the project's progress. The last challenge we have is in getting the contract with our network design company in soon enough so that we can have the detailed designs needed to move forward on the department of transportation and tribal right of way approvals.
