1. Please describe significant project accomplishments completed during this quarter (600 words or less).

The Pyramid Lake Paiute Tribe has made significant progress on the NEPA draft. The US Fish and Wildlife Service has informed the tribe's Environmental Department which is preparing the draft that they will be signing off without any requirements. A late notice by the State Historical Preservation Office for the state of Nevada informed us that they will be requiring a Class 1 and Class 3 survey due to the scale of the project. We are in the process of hiring the credentialed Cultural Resource Specialist to perform these surveys. The Environmental Department has otherwise completed the draft NEPA report which will be submitted by the six month deadline. We have been informed by the NTIA that this will not necessitate an extension for the draft report.

After meeting with NITA program officers and senior grant officers during the NTIA broadband conference, our selection of the prime contractor during the application phase will meet their approval for our procurement procedures.

The process for the formal agreement with our telecom for the acquisition of the section of dark fiber from the reservation boundary into Reno, NV is progressing. We have made contact with the telecom representative and the tribal attorney will be working with another law firm with expertise in this area.

We have completed the job description for the Project Manager position and the personnel committee has approved the new classification. The tribal council is waiting on a progress report with the dark fiber acquisition for final approval. This is due to our reliance on this agreement as a significant portion of the tribe's in-kind match.

The acquisition of the tribe's IRU for the dark fiber to Reno involves the tribe's attorney, and progress seems to have been hampered with the holiday season and the attorney's schedule. The EA draft plan is on schedule, but the late notification by the SHPO for the survey requirement has us pushing to get the RFP out. We estimate to have the mapping for the cultural resource specialist and the material for the SHPO ready in the next guarter.
