Thre primary efforts of the Carver County Open Fiber Initiative (CCOFI) project team related to our environmental assessment (EA) in which the County worked withy and received final conclusion communications from the various tribal entities with interest in our project; we finalized our meetings with all community anchor institutions (CAI's) relating to grant submitted laterals as well as gathering information on potential future optional add on laterals; the County reached out to various service providers such as telco's cable companies, wireless providers to discuss the project and potential interconnection opportunities; the County hired a consultant to complete an archaeological review of the project and received a final report that was submitted to MN SHPO for review. Other non environmental assessment project efforts focused on futhering our construction partner contract negotiations, hut permitting, the initial drafting of a community outreach packet for use by our CAI's, furthering the formation of our Broadband Initiatives Taskforce (BIT) which will act as a project communication and sounding board entity relating to the project, and creating a more robust and useful fiber public information website regarding our project; and unrelated to the funding of the ARRA project but critical to an interconnection point to the CCOFI fiber ring is the termination of the fiber connection between the Carver County and Scott County Gov't Centers.1
