The most largest accomplishment Merit will have established by the end of next quarter is draft submission of the environmental assessment. Merit will also have completed some of the field engineering as well as started the procurement procedures for equipment, fiber, materials and construction. Considering field engineering will start permitting will start and preparation for construction will get underway. Merit also anticipates the negotiation for the hut sites to be initiated as well as negotiations for the IRU for the Mackinaw Bridge to resume and the purchase of fiber from St. Ignace to Saute St. Marie. Construction will start if the FONSI is awarded before March and the permits are complete. Although construction is unlikely this quarter Merit feels the process will be streamlined enough to build the fiber at a rapid pace if we are able to complete those two big hurdles.

Some challenges we forsee facing is a lack of resources given the vast amount of work in the State. Given that this industry is growing rapidly via the ARRA grants the capacity of engineers, construction companies, suppliers is being restricted. This may make it difficult to secure these important materials and services without paying a higher amounts and having longer lead times than anticipated. Due to Merit's "high" profile project we have not had these issues but we may be seeing the impact in the next guarter or future guarters to come. Permitting will continue to be our number one obstacle consider work will take place in multiple states given that we are unfamiliar with their practices and procedures. Merit has consulted with firms that are familiar with the process and they will be able to assist us in that process. By assisting us in the process this will help us mitigate these permitting issues. Although Merit will be able to catch up on the amount of work this quarter Merit will not be able to procure all the services that it has initially anticipated given the restriction of funds via the Environmental Assessment SAC. We feel Merit will be able to mitigate this issue in future quarters by catching up given that many if not all agreements will be in place.
