Overall Project:

-During the 4th quarter of 2012, 157 residents completed computer training, advancing their technological knowledge, and 57 computer devices were purchased by residents.

Equipment:

-No additional equipment was purchased during this quarter.

Outreach Activities:

- -Tampa Housing Authority's BTOP Team advertised computer training and computer sales through door to door flyer distribution, telephone calls to residents, and mail-outs in both English and Spanish.
- -Computer Sale Events were held at least twice a month on various properties to accommodate as many residents as possible.

Training Programs:

- -The 4th A+ Certification class was completed on December 28, 2012 with a total of three successful participants.
- -Computer Essential Classes were provided in both English and Spanish, through STC Partners, at various times and various days of the week on multiple properties, reducing transportation issues and accommodating different schedules.

Job Creation:

There were four residents to make up the MOB (Maintenance of Broadband) Squad who conducted repairs reported by the residents. Currently, the MOB Squad consist of three residents due to one member's success in securing a full time job with a company providing Customer Service/Customer Support to end users.
