In Idaho, library users go to libraries to find jobs, create new careers, improve skills, learn to use the latest technology, get the tools and information needed to

reenter the workforce, and help grow small businesses. Libraries provide a vital link to technology and information. Over 70% of Idaho's public libraries are the only free source of Internet access in their communities.

92.6% of Idaho's public libraries help people access and use employment resources, helping with job searches, creating resumes, and submitting employment applications. Public libraries also partner with the Idaho Department of Labor to provide access to the Idaho Career Information System, IdahoWorks, and other Labor resources. 81.9% of Idaho's public libraries offer computer and other technical training, helping people gain essential technology skills for the 21st Century workforce.

BTOP funds have expanded Internet access to 49 libraries that before had only limited access to the Internet, enabling them to offer residents in their community access to these web-based resources and services. Three series of workshops have brought together the library staff from these libraries with Idaho Department of Labor case workers and regional managers as well as staff from the Idaho Division of Professional/Technical Education, Adult Basic Education programs to share resources and programs and plan outreach and end-user training focused on resources for the un- and under-employed, locally.

BTOP funds also enabled a statewide subscription to LearningExpress Library with resources for self-instruction to build computer skills and tools to study and practice for licensing and certification exams and GED, SAT, ACT, and TOEFL tests. Users have used 3652 resources to build computer skills and 2833 resources for career and professional development from this online resource.

• Sustainability: E-Rate training for public library staff was the first thing done.

• Statewide Technical contract specialist hired to handle bid process and contract negotiations for expanded bandwidth for the libraries, as individual installations ensuring compliance with E-Rate rules and appropriate technical plans for each library.

- Statewide launch gathered potential partners and generated top-level support for collaborations.
- Promo: kit with "online @ your library" materials to promote the availability of the expanded broadband and resources
- Promo: television spots promoting the new resources available to Idaho
- Promo: Radio spots on college football and basketball game days
- Promo: Spanish radio and TV spots
- Promo: library launch kits to generate community awareness
- Collaboration: Partnering with other state agencies
- Collaboration: leveraging existing resources within the state (Apangea, PLATO, E-gov, IdahoPTV video, etc.)
- Resources: Providing resources statewide (LearningExpress Library, Internet2 membership)
- Resources: Developing new statewide resources (Scout, online job-seekers handbook)
- Regional and very local workshops to connect resources & local partners
- Youth Corps digital literacy coaches for computer users at the BTOP libraries

Expanded broadband

The Commission matched individual BTOP libraries with the lowest-cost providers for broadband Internet service in their particular communities. In addition, up to 90 percent of the Internet bill for the libraries will be paid by the FCC E-Rate Universal Service Fund. Most of the libraries are also getting wi-fi equipment that will enable library patrons who bring their own computers to the library to access the Internet.

Online resources

LearningExpress Library has been well-used since the BTOP-funded

statewide subscription became available in November 2010. At libraries throughout the state, jobseekers and students are using LearningExpress Library courses for reading, writing, math, and computer skills; study guides for academic tests such as the GED and SAT; and a wide array of career certification preparation and practice exams.

Statewide online resources coming in summer 2011 include "Scout" (a version of Teachers' Domain customized for Idaho students) and Internet2 resources for libraries. Like LearningExpress Library, these resources will be available through the LiLI portal at www.lili. org.

Library and partner training

Training is a key component in the "online @ your library" project, and staff members from BTOP libraries completed E-Rate training as well as training for newly available online resources.

BTOP libraries also participated in "Connecting Resources & Partners Workshops" held throughout Idaho during the first year of the project. These workshops connected BTOP libraries with their local grant partners—such as the Idaho Department of Labor and Adult Basic Education—and provided hands-on access to the various resources available to all Idaho residents through the BTOP project. Promotion

BTOP libraries got a kit with "online @ your library" materials to promote the availability of the expanded broadband and resources. In addition, all public libraries got table-top displays to place near their public access computers to show computer users where to find valuable online resources. Idaho Public Television produced and aired television spots promoting the new resources available to Idaho residents at www.lili.org.

End-user training

During the summer and into the fall "digital literacy" coaches were available to computer users at the BTOP libraries. The Idaho Department of Labor field offices matched Youth Corps participants with BTOP libraries. The Youth Corps participants worked part-time in the public libraries, assisting patrons with basic computer skills.

The Department of Labor also leveraged their existing resources for jobseekers to develop an online "Idaho Jobseekers Handbook." Collaboration

Partnering with other state agencies for the "online @ your library" project benefits not only the Commission and Idaho public libraries, but also the partnering agencies. While

the libraries learned about the resources available to their communities, staff at partnering agencies learned what the libraries across the state have to offer and have been "simply amazed" by the discovery. Partners found workshops and presentations provided by ICfL to be "very professional and informative." They also appreciate outreach efforts on the part of the Commission to raise awareness

about the BTOP project and leverage existing resources within the state. Partners are looking forward to using the information gathered at these sessions to design larger workforce services initiatives.

The call out for our "best practices" is nicely summarized in this comment from a foundation program officer working with us on this project:

"AFTER REVIEWING YOUR NTIA AND FOUNDATION REPORTS, I CONTINUE TO BE IMPRESSED WITH THE WORK OF THE IDAHO COMMISSION FOR LIBRARIES. THE ACHIEVEMENTS YOU HAVE MADE IN PROCURING BROADBAND UPGRADES AND ERATE PARTICIPATION ARE IMPRESSIVE. SO ARE THE NUMBERS. \$290K IN ERATE SUPPORT FOR 43 LIBRARIES WITH PLANS FOR EVEN MORE IN THE NEXT ERATE CYCLE; UPGRADES FROM AN AVERAGE OF 1.5MBPS TO 11MBPS; A DIVERSE SET OF CARRIER CONTRACTS; 477 COMPUTERS ORDERED AND 287 INSTALLED IN LIBRARIES; DIGITAL LITERACY TRAINING THROUGH THE IDAHO YOUTH CORPS; AND PARTNERSHIPS WITH THE DEPARTMENT OF LABOR, ADULT BASIC EDUCATION, WGBH, PBS AND IDAHO PUBLIC TV."
