We have 2 challenges that we faced during Q1 of 2012. First is the AAR Budget Modification request, which we are waiting for a response on. The other involves our "existing" PCC @ Gallegos Lane Community Center. As reported in previous reports, the SF Boys & Girls Club was using and managing the facility as a Teen Center. But, in February of Q1 - 2012, they informed us that they were closing the site due to funding issues. We have begun to search for another organization to use/manage the PCC and make it available to the public again. This will slightly effect our user #'s in Q1-2012 and Q2-2012. Through Q1 of 2012, SFCHA has provided in additional matching funds, \$15,739.34 for personnel and \$15,548.16 for fringe benefits.
