10. Personnel

10a. If the project is not fully staffed, describe how any lack of staffing may impact the project's timeline and when the project will be fully staffed.

Currently, two projects are impacted by not being fully staffed. They are the Broadband Program Office (Capacity Building) and Street Address Mapping (Address File) project. The Broadband Program Office is supposed to be staffed with two full-time employees paid for with SBI grant funds. These are Project Manager and Outreach Coordinator. Due to difficulties caused by a State hiring freeze policy, the PM position was never filled. In September, the Office was given a hiring freeze waiver for a lower grade level Project Assistant position. The expectation is that this new position will be filled during Q4 2012. The Broadband Program Office Director (a position not funded by the SBI grant) has researched vendors that can assist meeting some of the milestones not yet met per the current project timeline. Vendor procurements will be worked on in Q4 2012 and Q1 2013.

For the Street Address Mapping project, the project team will be issuing a Request for Proposal in November, 2012. The selected vendor will supply the additional staffing required to complete the project by September 2014.
