Project Indicators (This Quarter)

1. Please describe significant project accomplishments completed during this quarter (600 words or less).

On January 11, 2012, Legal Aid of North Carolina (LANC) hosted a Continuing Legal Education Program (CLE) for its attorneys throughout the state. During the quarter, LANC hosted two other CLE's.

On January 12, 2012, North Carolina Central University (NCCU) School of Law (SOL) started its second undergraduate course for students at NCCU and the partner institutions. This course has been highly successful in preparing undergraduate students for law school. To date, three students (two at NCCU and one at Winston Salem State University) have been accepted to NCCU SOL for Fall 2012.

On January 21, 2012, NCCU SOL had a Foreclosure Prevention Workshop. Throughout the first quarter, multiple one-on-one foreclosure prevention sessions were held for homeowners across the state.

On January 25, 2012, NCCU SOL hosted a forum called "The Real American Gangster: The Truth, The Whole Truth and Nothing but the Truth." In this session, Professor Irving Joyner moderated a panel discussion on the intersection between race, crime, and discrimination as it relates to an examination of the history of the U.S. military, New York Police Department, and North Carolina prosecutors in their investigation and prosecution of a major drug operation in the 1970s. Guest panelists were the Honorable Sterling Johnson, Leslie "Ike" Atkinson, and Ron Chepesiuk.

On January 26, 2012, NCCU SOL had an Eagle Empowerment Seminar called "Your Rights and Responsibilities as a Future Entrepreneur." In this session attorneys discussed how to create a business and the pros and cons of starting a business.

On February 21, 2012, NCCU SOL and Fayetteville State University's Pre-Law Society hosted a Pre-Law Forum for students at the partner institutions interested in law school.

On February 21, 2012, NCCU SOL's Family Law Clinic had a File It Yourself Clinic for child custody with two LANC offices – Durham and Pittsboro.

On February 22, 2012, NCCU hosted a Hazing Awareness Forum with participation from the partner institutions.

On February 25, 2012, Dean Pamela Glean gave a presentation at the 6th Annual Minority Landowner Magazine Conference. She gave a live demonstration of the Technology Assisted Legal Instruction and Services (TALIAS) Project, introducing its potential to increase rural landowners' access to legal services.

On March 21, 2012, NCCU School of Law Domestic Violence Clinic started a Breaking the Silence Series with its first session called "Ethan's Law." Mrs. Effie Steele, a leading domestic violence advocate in North Carolina spoke about her personal story about domestic violence and how she was instrumental in the passing of Ethan's Law.

On March 8, 2012, NCCU SOL had an Eagle Empowerment Seminar called "Social Networking and Liability Issues." In this session, panelists discussed how students should be aware and cautious about the information that they are putting on social networking sites. On March 15, 2012, NCCU Public Relations (PR) Director, Ayana Hernandez, hosted a PR Directors Meeting for the partner institutions to start a new collaboration. The Virtual Justice Broadband grant allows the PR Directors to share ideas, opportunities, and strategies. This meeting was the first of quarterly meetings.

On March 21, 2012, NCCU SOL Domestic Violence Clinic held its second Breaking the Silence Series with its first session called "Civil Domestic Violence Protection Orders." Attorneys discussed obtaining protection orders in North Carolina from the perspectives of both the plaintiff and defendant.

On March 27, 2012, NCCU SOL Family Law Clinic started a Child Support and Custody series with its first session called "Child Support: It's More than Money." Panelists discussed the importance of paternity testing, how child support is determined, and the types of child support orders.

All TALIAS events and sessions used HD videoconferencing.
