On April 2, 2012, Legal Aid of North Carolina (LANC) hosted a Continuing Legal Education (CLE) Program on Amendment One for its attorneys throughout the state.

On April 10, 2012, North Carolina Central University (NCCU) School of Law's (SOL) Domestic Violence Clinic continued the Breaking the Silence Series with its second session called "Same Sex Couples' Reluctancy to Report Crimes." In this session, attorneys discussed access to civil protection orders and support services in domestic violence situations.

On April 12, 2012, NCCU SOL held a Multi-Campus Forum with HBCU military students at NCCU and our partner institutions. The guest speaker was Attorney Will Gunn, General Counsel for the United States Department of Veterans Affairs.

On April 17, 2012, NCCU SOL's Family Law Clinic hosted a Child Support Session. Participants learned how to file child support modifications.

On April 19, 2012, NCCU SOL had an Eagle Empowerment Seminar panel discussion on the death of Trayvon Martin called, "The Unspoken Conversation that has Become the Talk of the Nation."

On May 8, 2012, NCCU SOL started an Immigration 101 series. In the first session, "Can I Become a Lawful Permanent Resident," participants learned ways foreign nationals can become lawful permanent residents in the U.S.

On May 17, 2012, NCCU SOL held the second session in the Immigration 101 series, "Are the Police Out to Get Me." In this session, participants were given information on driver licenses and social security issues. LANC held a child custody clinic for participants in Durham, Fayetteville, Gastonia, Wilson, Sylva, New Bern, Morganton, Greensboro, Raleigh, Pittsboro, and Winston-Salem, North Carolina.

On May 19, 2012, NCCU SOL started its Justice in the Practice of Law Summer Certificate Program. The courses are taught from NCCU and the students use a desktop videoconferencing client and broadband to connect to class. The students are taking the courses from North Carolina, South Carolina, Virginia, Florida, Mississippi, and Louisiana.

On May 21, 2012, NCCU SOL's Family Law Clinic held a child support session for residents of Fayetteville, NC. In this session, the attorney discussed the process for establishing child support show.

On May 24, 2012, NCCU SOL held the third Immigration 101 session, "What's New? Changes in Immigration Law and Procedures." Attorneys discussed the Dream Act and other immigration remedies.

On May 29, 2012, NCCU SOL held the final session in the Immigration 101 series. In the "Know Your Rights" session participants learned what foreign nationals should know about protecting themselves while living in the U.S.

On June 1, 2012, LANC hosted a CLE on Medicaid issues for its attorneys throughout the state.

On June 5, 2012, NCCU SOL's Tax Clinic held a session for individuals that had an IRS deficiency, were being audited, or engaged in litigation with the IRS.

On June 19, 2012, NCCU SOL's Family Law Clinic held a child support session called, "Child Support Show Cause Orders." In this session, the attorney discussed contempt orders and incarceration for nonpayment.

On June 20, 2012, NCCU Public Relations (PR) Director, Ayana Hernandez, hosted a second meeting with the PR Directors at the partner institutions. This will be a continuous quarterly meeting.

Throughout this quarter, multiple one-on-one foreclosure prevention sessions were held for homeowners across the state.

TALIAS events and sessions used HD videoconferencing, telepresence, and broadband.
