Project Indicators (This Quarter)

1. Please describe significant project accomplishments completed during this quarter (600 words or less).

On October 5, 2011, NCCU School of Law had its second Eagle Empowerment Videoconferencing Seminar called "Your Credit, Your Money and the Law." Professor Timothy Peterkin discussed collections actions, protecting your credit score, financial scams and other issues that impact your money and credit.

On October 28, 2011, Legal Aid of North Carolina (LANC) hosted its first statewide videoconferencing Continuing Legal Education (CLE) program. Attorneys participated in this program at NCCU School of Law, fourteen LANC offices and there were a total of 171 participants.

On November 2, 2011, NCCU School of Law had its third Eagle Empowerment Videoconferencing Seminar called "Your Roadmap to Understanding and Avoiding the Criminal Justice System." Two successful local criminal defense attorneys discussed privacy rights, search and seizures laws and other aspects of the criminal justice system. This seminar had a record-breaking number of 321 participants.

On November 9, 2011, NCCU School of Law's Family Law Clinic had its first Videoconferencing Child Custody File It Yourself Clinic with two LANC offices – Durham and Pittsboro.

On November 11, 2011, Dean Wendy Scott participated in an invitation only roundtable discussion on distance education in law schools. TALIAS was discussed. This conference was hosted by Harvard Law School. A follow up session is scheduled in April 2012 at Dayton Law School in Dayton, Ohio.

Pam Glean participated in a panel discussion at a Poverty Law Conference at UNC Chapel Hill about "The Future of NC Access to Justice." She spoke about TALIAS and how it is helping to increase the institutional adoption of broadband in North Carolina.

On November 16, 2011, NCCU School of Law hosted its first National Virtual Open House. Prospective students participated in a live town hall setting with the Dean, Student Bar Association President, Legal Clinic Attorneys, Professors, and Admission Officers. A total of 27 participants were connected by broadband via desktop videoconferencing and our four partner institutional sites.

On November 17, 2011, BTOP staff conducted a Monitoring Site Visit and had a chance to witness our project first hand. They also visited Winston Salem State University and North Carolina Agricultural and Technical State University.

On December 3, 2011, NCCU School of Law had its first Landlord and Tenant Workshop called "What Tenants Should Know to Protect Their Rights." In this session an attorney from the Durham Legal Aid Office discussed evictions, safe rental housing, repairs, and security deposits.

On December 12, 2011 and December 13, 2011, the TALIAS team visited Valdese, Morganton, and Asheville, North Carolina. The team met with Beverly Carlton at Olive Hill Community Economic Development Corporation, Inc., a BTOP grant recipient in Morganton, North Carolina. Mr. Clinton and Ms. Glean shared with Ms. Carlton their experiences and gave advice.

On December 13, 2011, the team met with Scott Hamilton with Advantage West and Jim Barnett with Pisgah Legal Services (PLS). PLS serves six counties in western NC. Both were excited about TALIAS and wanted to get involved in the project. The team met with Asheville, NC Mayor, Terry Bellamy. Mayor Bellamy had visited NCCU School of Law in the fall of 2011 and was interested in TALIAS and wanted the program to have a presence in Asheville. PLS will receive three HD mobile videoconferencing units so that TALIAS will have a stronger presence in western NC.

As part of TALIAS' expansion and sustainability efforts, the team is applying for additional funding. There have been a series of videoconferencing sessions with Southern University Law Center in Baton Rouge, Louisiana to expand TALIAS to Louisiana.

This quarter, NCCU School of Law hosted a National Collegiate Athletic Association (NCAA) meeting using HD Videoconferencing. Athletic departments at thirteen universities participated. There were 51 participants. The meeting was such a success that we will continue to host these meetings during the next quarter so that we can expand the institutional adoption of broadband through TALIAS.

We plan to add TALIAS equipment in five locations. Pisgah Legal Services will receive three HD mobile videoconferencing units so that TALIAS will have a stronger presence in western NC. The Conflict Resolution Center in Durham, NC and The Dispute Settlement Center in Carrboro, NC will also receive TALIAS equipment. NCCU School of Law will work with the two mediation centers to do mediations by videoconferencing.
