The WorkForce Public Computer Center (PCC) modernization project promotes economic recovery by providing the under and unemployed with multiple tools that can enhance their existing skills and aid in the job search: a) each machine is equipped with the latest versions of Windows and Microsoft Office, keyboarding skills software, and resume preparation/coaching software; b) each office is equipped with a multifunction printer-copier-scanner that can provide hardcopy documents and e-mail scanned documents to potential employers; and, c) the high-speed Internet connection allows the use of on-line tools such as ACT's KeyTrain and the AARP WorkSearch program to assist job seekers in career readiness and identifying suitable employment opportunities in addition to typical on-line job search activities. In addition to KeyTrain, WorkForce is also offering WorkKeys testing at select PCCs so that job seekers can earn a Career Readiness Certificate that demonstrates proficiency in key workplace skills. WorkForce is also utilizing the Skype video conferencing machines to promote remote interviewing for job and training placement. Lastly, WorkForce staff members are uniquely equipped to understand the local job market and what types of positions are in demand from which employers. In addition to assisting users with basic computer and Internet skills, WorkForce staff can help job seekers tailor their resumes and online applications for positions that are most needed or showing job seekers the type of training or certification they will need to be more competitive in the local job market.
