In the **Other** category the project manager and grant administrator have been hired. The grant administrator has been working with the NTIA on compliance regulations, establishing project report structures, completing required reports and administering the project RFP. The project manager has driven and defined the fiber route including aerial and underground locations and river crossing. Contacts have been made with facility owners (i.e. power companies, pole owners, ISD's State of Michigan DOT, etc. to determine the **Right of Way** category issues. Pole and conduit agreements are being written and signed. Pole ownership information is still being collected. In the **Environmental Assessment** category an RFP for the environmental assessment was written and posted and responses are being evaluated. Under the **Equipment Procurement** category the optical equipment is being reviewed. Partner meeting was held and a temporary MOU was distributed. Exact contract language is being determined. Approximately \$130,000 of grant supported funding will have been expended.

The most challenging aspect so far has been to meet the deadlines and clearly understanding all the compliance issues related to the project and how those will be incorporated into the corporate structure. Merit accepted the grant on January 22, 2010. The clock was ticking before Merit even became aware that they were awarded the grant, the environmental assessment has a sixth month time limit and that began January 1, 2010. Meetings with the NTIA did not begin until mid-February. A great deal has been accomplished in a very short time period and Merit expects to make great progress in the next quarter.

The grant administrator and the project manager continue to work on project related issues under the **Other** category. Also in that category a legal consultant will be hired to draw up the partnership contracts. In the **Environmental Assessment** category the environmental assessment consultant firm will be reviewed and hired. Several meetings will be held with the firm to determine the quickest course of action including contacting the SHPO in THPO. Detailed mapping will be completed after the route is driving several times and sections walked to determine the exact placement of poles and trenching. Alterations will be made after the environmental assessment firm identifies any possible issues. The alterations will be submitted for approval to the NTIA. The environmental assessment should be completed by June 30, 2010. An RFP for engineering, in the **Network Design** category, will be posted, reviewed, and a firm hired. It is expected that the engineering design work will begin in late May and continue to the end of June with approximately 35% of the design work completed so that early building can commence in the next quarter. Over 60% of the **Right of Way** category requirements will have been identified and permits submitted for the early build portion. Work will begin on the Metro Act permits. Trips to tour fiber company facilities, in the **Equipment Procurement** category, within the United States will take place in May. RFPs will be posted for materials and construction and vendors reviewed and selected. The optical equipment and other related materials will also be selected before the end of June and many of the orders will be placed. In the Equipment Approximately \$372,000 of the grant funded portion of the project will have been spent.

The biggest challenge will be to complete the environmental assessment before June 30, 2010. State agencies require 60 to 90 days of response time with the possibility of requests for additional information. Although we posted the environmental assessment as soon as possible after our first consultation with the NTIA that left us only 120 days for completion of the environmental assessment.
