The CTDOL is committed to the pursuit of technology in our service delivery model. This grant will provide the statewide infrastructure to allow us to succeed in that approach.

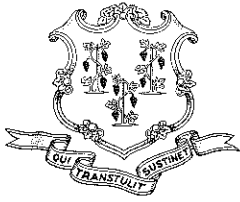

On behalf of Northwestern Connecticut Community College, I am writing to express support for the Broadband Technology grant proposed by the Connecticut Department of Information Technology to expand access to information and instruction through the Connecticut Education Network.

Northwestern Connecticut Community College serves approximately 1,700 credit students each semester with a slightly smaller number of non-credit students enrolled throughout the year. Since 2000, headcount enrollment has grown by 7% and full-time equivalents have increased by 27% in the same time period. In order for these students to gain the knowledge needed to advance to higher levels of education and to enter the workforce with the skills required by Connecticut's competitive job market, they must have access to the most advanced educational technology and the latest information available. The inclusion of our college in this ARRA Broadband Grant means that we will be capable of supporting the kind of education our internet-savvy younger students require. In addition, with fifty percent of our non-credit enrollments focused on workforce development, students who are training or retraining for a career will have the resources necessary to support their efforts. It is important to note that the two largest towns in our service area, Winsted and Torrington, have unemployment rates of 12% compared to the State's average of 9.8% and the median income is \$13,000 below the State's median income. Torrington's poverty rate is 11%.

We are located in a sparsely populated area of the State, yet cover a very large geographic area. The higher cost for connection has made access unavailable within CEN funding. Connecting our facility will be a major improvement in the educational environment for students and will result in major improvements to the internet environment in this part of the State. For example, the Office of Rural Health is located at our college and improved broadband will assist health care providers (EMTs, hospital emergency rooms, etc.) in improving communications and the sharing of data.

I welcome the opportunity to support this innovative proposal and look forward to working with the Department of Information Technology to strengthen and expand the Connecticut Education Network.

I am writing in support of the Department of Information Technology's application for a Broadband Technology Opportunities Program grant. Receiving our Internet connection through CEN has made it possible for our Library to provide fast Internet service to our patrons. Increasing the broadband capacity of our Library to a fiber connection would greatly improve what we can offer.

At our small library use of our public access Internet computers has been steadily increasing. Currently, we have seven public access Internet computers and use is up 41% since 2006. Many people do not have, or no longer have, Internet service or a computer at home; some want a faster Internet connection; some patrons just want a quiet place to work. Patrons are job hunting, checking e-mail, doing homework, checking into health issues, etc. Some days they are filled all day long.

We are always trying to respond to our patrons' needs and requests. Having Internet computers available at the Library is becoming an extremely important service we offer. Having a fiber connection to the Library would allow us to provide the best service we can to our patrons and would let us expand what we will be able to offer in the future. I hope you will favor this application for this most important service, for our Library and other public libraries in the State of Connecticut.

I am writing in support of the Department of Information Technology's application for a Broadband Technology Opportunities grant. The Brookfield Library has had a Connecticut Education Network (CEN) line for the past few years. Because of the extremely heavy use of the library's Internet-accessible computers, and the bandwidth used by the library's online circulation software, the CEN connection speeds are no longer adequate to meet our needs.

Patron complaints about Internet connection speeds have led us to contract with Charter Communications for a higher-speed Internet connection. Charter had provided a basic connection at no cost to the library, but we are now paying \$50/month to be able to pull some of our traffic off the CEN line and transfer it to the cable modem. In this time of increased use and reduced funding, that \$600/year, as well as the \$600 piece of hardware required, could be better spent for many other line items.

Area residents seeking jobs, the shift of many resources from print to online, and the growing use of Web 2.0 tools are factors in patron expectations of their public libraries. Increased bandwidth through the CEN will allow us to continue to provide the level of service patrons have come to expect from The Brookfield Library.
