REASON(S) FOR AMENDMENT During initial site walks for the 5 proposed tower locations, we discovered that one of the sites was not suitable for a tower to be installed. We were able to find a replacement tower site approximately 7 miles from the initially proposed site. The new site offers a number of advantages over the unviable site. The unviable site was approximately 4 miles from one of the other sites; by moving the site 7 miles to the southwest, the wireless coverage patterns will improve for a larger area of the county. The project budget and timely completion of the project will not be affected. The new tower location is included in the Environmental Assessment that has not been completed yet.
