REASON(S) FOR AMENDMENT While designing the network to support our proposed and long term service offerings, it was determined we needed to revise our fiber count plan on various routes. The original fiber plan had 144 fiber counts with 24 fibers for each anchor tenant. The revised fiber plan has fifty percent (50%) 288, twenty-five percent (25%) 144, twenty-five percent (25%) 48 with 12 fibers for anchor tenants. The revised fiber plan will facilitate two fiber rings to provide additional network redundancy while allowing for future expansion in areas designated as ?underserved/unserved?. I have included a map showing the revised fiber count routes including the unserved and underserved areas of the project. The project budget and timely completion of the project will not be affected. The revised routes are included in the Environmental Assessment that has not been completed yet.
