During the second quarter of 2010, we completed our planning process for our Wave 1 deployments. We are slightly delayed in completing one of our key vendor contracts due to the new vendor contract requirements provided by BTOP during late June; however, we expect to have a fully-executed contract with this key vendor in August 2010 and immediately complete right of way determinations and access, and begin obtaining our construction permits and other approvals for the fourteen (14) sites in Wave 1. As part of our process to finalize Wave 1 deployments, we not only confirmed the specific service needs with each of the community anchor institutions to be served, but we also spent significant time re-confirming that each of the locations we will serve in this Wave still do not have commercially reasonable service options other than through our BTOP grant.
