

Please accept this letter as an expression of support from the Florida Department of Transportation (FDOT) for the Opportunity Florida / North Florida Economic Development Partnership / Florida's Heartland Rural Economic Development Initiative application for the Rural Utilities Service Broadband Initiatives Program. These three Rural Areas of Critical Economic Concern, designated by the Governor of Florida, have come together to pursue funding to help deploy a regional broadband network in the three rural regions of Florida. By providing much needed communications infrastructure to the twenty eight rural counties, opportunities for economic development will increase and quality of life will improve in rural Florida.

Currently, Sections 337.401 - 337.404, Florida Statutes and Rule 14-46.001, Florida Administrative Code allow communication lines access along the State Highway System, other than limited access right-of-ways. All utility owned facilities on Florida Department of Transportation rights-of-way must be authorized by permit and all utility design work, to the extent allowed by Florida law, must comply with FDOT requirements. As long as each rural county submits permits with designs in accordance with the current FDOT Utility Accommodation Manual, the Florida Department of Transportation will issue the necessary permits.

Intrinsic Value and Stability of State Right-of Way

According to a report issued by the Federal Highway Administration to Congress in 2007⁵, using a state department of transportation as a right-of-way provider eliminates some risks that would otherwise accompany having a private entity as the right-of-way providers. The risk of bankruptcy of the right-of-way provider and potential rejection of the right-of-way agreement by the bankruptcy party is much lower when the provider is a governmental entity. To the extent the right-of-way grant can be made in the form of an

easement, the telecommunications company partner enjoys even greater stability of the right-of-way grant under state property laws.

Value of State Right-of-Way

Due to drastic differences in rural land values across the state and the lack of exact corridor alignments, right-of-way values reflective of the specific corridors are not available at this time. Recognizing Florida Statutes allow utilities (including telecommunications/broadband) to be placed on non-limited access right-of-way without a permit fee, utility applicants are not required to purchase easements from adjacent landowners. In comparison, some states require applicants to purchase such easements for locating utilities and/or pay a permit fee to the state.

Fortunately, this cost will not be incurred by the applicant if they comply with Rule 14-46, Florida Administrative Code and the FDOT Utility Accommodation Manual when designing their facilities. Therefore, for purposes of valuing the necessary right-of-way for this project, one may assume this cost alleviation/avoidance to the applicant as the Florida Department of Transportation's in-kind match for the Broadband Initiatives grant application.

Thank you for initiating this effort to help strengthen the information infrastructure across rural America. In addition to the direct benefits to the rural areas, such a project would increase the Department's future opportunities to co-locate Intelligent Transportation Systems (ITS) in state-owned right-of-way in these rural counties. For these reasons, the Florida Department of Transportation is committed to serving as a key partner in meeting the challenge of rapidly expanding the access and quality of broadband services in rural Florida.

On behalf of the North Florida Broadband Authority I am submitting this letter in support of the Florida Rural Broadband Alliance's application for Round 2 BTOP funding. The NFBA was awarded \$30 million in Round 1 of the BTOP program to construct a broadband middle mile network to serve the North Florida Rural Area of Critical Economic Concern (RACEC). The NFBA region covers 15 counties and 8 cities in North Central Florida. The FRBA is a regional collaboration of local and tribal governments, economic development agencies and community activists from rural and economically disadvantaged communities located throughout 15 counties within the Northwest Florida RACEC and the South Central Florida RACEC seeking to expand access to broadband infrastructure throughout their regions. The approval of FRBA's grant application would ensure the expansion of access to broadband facilities throughout the 30 rural counties within the 3 Florida RACECs included in the NFBA and the FRBA service areas. The counties within the three Florida RACECs share common challenges and characteristics of persistent poverty, unemployment and under-education. The RACEC designation for the communities within the FRBA service area demonstrates the extraordinary needs of the citizens and businesses in these communities for educational improvements, job creation and economic development that can be spurred by the expansion of broadband facilities.

The NFBA network architecture was approved in large part because of its cost effective delivery of broadband middle mile capacity across large geographic areas. Further, the network design's utilization of existing towers and back bone assets promotes the "shovel ready" nature of the project by reducing the needs for environmental assessments and other site preparation work needed by other projects. 





I am writing this letter of support as the Library Director of the Calhoun County Public Library System. We have 5 facilities located in the very rural area of Northwest Florida. We have a total of 108 computers. The Blountstown Library serves as our headquarters facility. Each of the 5 buildings has fragmented DSL lines to the buildings and a combination of hardwiring and wireless inside. The Blountstown Public Library's connectivity is of particular concern as we have 60 work stations plus a laptop wireless lab with insufficient bandwidth to meet public and staff needs. Mark Flynn, our State Library Consultant, in an e-mail about the Blountstown Library, said, "I don't think a T1 will be enough bandwidth. To be fair to your users you probably need at least 25 MB connection".

Calhoun, Jackson, Washington and Holmes Counties are identified as Rural Counties of Critical Economic Concern; the public libraries in these four counties are struggling to provide sufficient broadband to support public service requirements. The increased demands of e-government, e-commerce, and e-books along with SIRSI, a very sophisticated circulation system, is requiring more bandwidth than we are able to obtain and/or afford.

The Calhoun County Public Library System received a \$35,000 cut in State Aid this year and has been told to anticipate another \$30,000 next year. The Department of Children and Families as well as Federal agencies are sending clients to these public libraries to access their services. Large Federal and State Agencies are stressing our already inadequate connectivity in attempts to serve citizens of this county. If the rural public libraries are to be able to provide library services, circulate materials, provide e-mail, e-government, e-commerce and meet innovative challenges such as e-books and social networking we have got to have help. If Federal and State government expect to use library scaffolding to provide their e-services they have got to help libraries.

We look forward to participating in collaborative efforts with state, regional, local and community-based, and private partners in the development of an advanced broadband infrastructure. We need this network and we support its development.
