On May 11, 2012, Mississippi received a partial suspension from the National Telecommunications and Information Administration (NTIA) for all Long-Term Evolution (LTE) related expenditures. At that time, Mississippi had deployed the majority of its statewide LTE network. Mississippi was unsuccessful in its attempts to reach a Spectrum Lease Agreement with the First Responder Network Authority (FirstNet) for the continued use of the public safety broadband spectrum. As a result, Mississippi filed a Broadband Technologies Opportunities Program (BTOP) Grant modification with NTIA in December 2013 which was ultimately denied by NTIA.

Mississippi was allowed to finalize its capacity upgrade to the Mississippi Wireless Information Network (MSWIN) microwave backbone and continue the scheduling and installation of land mobile radios until December 31, 2013. Due to the inability to obtain spectrum for the use of the Mississippi LTE Network and the upcoming expiration of the original BTOP grant (September 2015), Mississippi had no choice but to commence with and finalize the deconstruction of the statewide LTE network.

On September 30, 2015, via Continuing Resolution, Congress extended the BTOP award to September 2020. The State has submitted a formal grant modification request to NTIA to use the remaining BTOP funds to improve public safety communications focusing on three components - the Mississippi Tele-Assist System, the Integrated Public Safety Communications Center, and mission critical data for public safety.

Final match reporting is included in this quarters report related to the phase 1 requirements.

The CCI percent's for this quarter and Next quarter Project indicators have been affected by the addition of the decommission of the LTE system and Financial audit performed on the Primary Grant recipient that had occurred in previous quarters but not included in the CCI project indicators percent reporting.

In addition, we have taken advantage of the end of phase 1 to adjust for rounding discrepancies in the Infrastructure budget execution details page.
