Dear Mr. Wagner:

I am the Chief Information Officer at Wayne State College in Wayne, Nebraska. I am also the Co-Chair of the Network Nebraska—Education Advisory Group that advises the State Chief Information Officer on the strategic direction of the statewide network. I am writing to express Network Nebraska's commitment to partner with the Nebraska Library Commission and participating Nebraska libraries in the Public Computing Center application for the Broadband Technology Opportunities Program. This partnership and the resulting programs will deliver new and expanded service offerings to provide enhanced literacy and educational opportunities for community members all over the State of Nebraska. In addition, we foresee the public libraries as becoming excellent partners with K-20 educational entities in providing statewide library materials through shared cataloguing, searching, and retrieving, as well as acting as interactive videoconferencing centers.

Nebraska public libraries, especially the smaller ones, have long suffered with deficient Internet bandwidth, outdated computers, and spotty technical support. In some special cases, like the Lincoln, Omaha, and Wayne libraries, there has been enough public support and partnerships to provide adequate Internet access for patrons and onsite computer labs. In many rural areas, public libraries provide the ONLY public computing access for citizens, vacationers, and home school students. In contrast, Nebraska K-12 districts and higher education institutions are operating with over 99% high bandwidth, fiber connections and over 75% of them are united over a single, statewide, Intranet network and backbone. Over 230 of these K-12 and higher education entities are working together in Nebraska to leverage more affordable Internet and higher bandwidth transport for mission-critical instructional and administrative applications.

By partnering with Network Nebraska on a more robust wide area network, updating personal computers, and sharing in the advantageous pricing of Internet access off of the state network, Nebraska public libraries could flourish in their provision of telecommunications services. Network Nebraska provides the statewide IP Intranet capabilities that Nebraska libraries could use to share common applications, deliver digital content, and also establish more endpoints involved in interactive videoconferencing. Network Nebraska also provides a 24/7 helpdesk for all of its members to help diagnose and resolve transport and Internet problems. The Network Nebraska Advisory Group has also recommended a limited time, no-fee trial membership for libraries as they first join the statewide network.

Broadband Internet access is the underlayment for all modern educational, administrative and business processes and is absolutely critical to the development of 21<sup>st</sup> Century skills. K-12 and higher education students are already in the habit of extending their learning environments to any time, any place, any path, and any pace. Nebraska libraries can be an essential component to any time, any place learning by coupling their electronic resources with print resources for K-20 students and their parents, but only if broadband connectivity is enabled. In addition, Nebraska K-20 education institutions welcome additional interactive videoconferencing endpoints on the network. These videoconferencing units can provide real-time interaction between patrons and subject experts; provide opportunities for continuing education; and also administrative video meetings to avoid travel.

If the Nebraska Library Commission is awarded this funding, this partnership will be strongly positioned to have a significant impact on addressing the digital divide for many economically challenged citizens, and also fulfill a vital function of providing an afterschool learning environment for many students.

Network Nebraska--Education appreciates the Nebraska Library Commission's submission and the National Telecommunications and Information Administration's consideration of this application.


We are writing in support of the Nebraska Library Commission's Public Computing Center application for the Broadband Technology Opportunities Program.

The Center for Rural Entrepreneurship works with communities and regions throughout North America. We have an office and staff based in Nebraska and Nebraska communities are a priority. Over the past 10 years we have worked in roughly one-third of Nebraska's counties on related projects. Our work's focus is community economic development. With this focus in mind we have identified two critical inter-related problems that can be addressed through this project.

**Economic Opportunity.** Even before the Great Recession most rural communities in Nebraska and even larger trade Center communities were struggling to create the right kinds of economic opportunity central to sustained prosperity. For most of these communities the key economic health trend lines were negative (e.g., depopulation, rising poverty, under-employment, aging, etc.). Continued consolidation in production agriculture coupled with erosion in manufacturing and loss of local business to major chains all have contributed to loss of economic opportunity. Traditional economic development focused on the once promising opportunity of industrial attraction (due to migration of industry from core cities to rural communities). However, business attraction has eroded as an economic development opportunity forcing rural communities to search for new economic development options. The Great Recession has dramatically deepened these already challenging trends.

**Demographic Stabilization.** Much of Nebraska has suffered for decades from chronic youth out-migration and population loss that significantly impacts the vitality of communities and the delivery of education, health care and government services including public libraries. It's not just the call of the city that compels young people to leave; it is also a perceived lack of opportunity and encouragement to "not come back" by adults that drives young people away from their hometowns.

We are however documenting very encouraging trends in our work with rural communities – a number of young people would prefer to stay or return to their hometowns if good career opportunities are available. The burgeoning interest in entrepreneurial careers combined with the desire to "come home" create significant opportunities for rural leaders to begin to reverse historic out-migration trends and revitalize their communities and public infrastructure.



Our extensive field work in Nebraska and elsewhere in North America provides promise that the combined strategies of entrepreneur focused economic development and youth attraction can provide the basis for a highly effective development game plan for rural communities. We have had the opportunity to work with rural communities for up to a decade where these strategies have begun to bend the trend lines in positive directions.

In most of the rural communities where we work in Nebraska we find the local library to be a center of discovery and learning. Libraries are generally very safe places where all residents can come and gain access to essential knowledge. We believe this reality is profoundly important to creating the greatest possible access. Enhancing state of the art telecommunications and broadband to rural libraries can dramatically increase access to information that can help rural communities become entrepreneurial communities. As entrepreneurial communities they can create a support environment that stimulates, supports and sustains entrepreneurs thereby growing the area's economy and increasing economic opportunities for all, but especially youth and young adults.

On the entrepreneurship front, the Center for Rural Entrepreneurship is excited with the opportunity to work with the Nebraska Library Commission and Nebraska's libraries to create greater access and use of business development services. We are prepared to support this project by sharing our extensive knowledge and business development resources.

Throughout North America we help communities and regions better organize themselves to prosper through support for area entrepreneurs. But reaching all possible entrepreneurs is challenging -- particularly those that are socially and economically disadvantaged. We believe this collaboration with libraries through this project can dramatically increase access, use and impact among all residents but particularly those who are disadvantaged and often reluctant to use more traditional sources of help. Libraries and broadband can create necessary access pathways.


There are remarkable web based resources in multiple languages that can be accessed with high-speed Internet technology. We are prepared to work with the Nebraska Library Commission to identify and access these resources through this project. Additionally, we are prepared to work with participating libraries to provide training on how to work with various kinds of entrepreneurs from new startups to struggling to successful wanting to grow.

Entrepreneurial youth exhibit the passion to create. When channeled and combined with entrepreneurial education and real world experience, they can build businesses with significant wealth and job creation potential over their lifetime. From our work with entrepreneurial communities across the nation, we are convinced that youth are essential to real and lasting economic revitalization.

To be successful, a multifaceted approach, or system, is needed to create and strengthen youth opportunities through:

- Youth leadership roles and responsibilities, working with adults
- Entrepreneurship education and career development
- Adult mentoring and support of youth and young adults

The youth engagement system helps youth create career opportunities through entrepreneurship, generational business transfer, and career pathways; and nurtures a sense of ownership and vested interest in the community's future as leaders. Community leaders who work with young people can also change attitudes among youth about the community and their future aspirations.



**Integrated Youth Engagement System** 

Under this proposal, the RUPRI Center for Rural Entrepreneurship will support the following youth engagement and entrepreneurship activities through Library Centers in three to five pilot communities:

- Deliver via video telecommunication technology in Library Centers training to teachers, youth program leaders and adult mentors in strategies and tools for successfully engaging young people in community economic development.
- Support information technology training for businesses by high school students using Library Center computer facilities, and demonstrate emerging technologies that local business owners and managers may adapt to grow their businesses and create new wealth and local jobs.
- 3) Deliver via video telecommunication technology in Library Centers, Energizing Entrepreneurs (e2) training focused on business coaching and youth entrepreneurship.

We are proposing a train the trainers approach coupled with on going mentoring support to create the greatest possible impact footprint. Activities will maximize the use of the technology deployed in library public computing centers to help ensure the greatest transfer of knowledge to all communities involved. If the Nebraska Library Commission is awarded this funding, this partnership will be strongly positioned to have a significant impact on addressing the problems and solutions we have described in this letter.

As the Nebraska State Court Administrator for the Nebraska Supreme Court, I am writing to express the Judicial Branch's commitment to partner with the Nebraska Library Commission and participating Nebraska libraries in the Public Computing Center application for the Broadband Technology Opportunities Program. This partnership and the resulting programs will deliver enhanced broadband capacity and access to essential court and legal resources for Nebraska's citizens and self-represented litigants through local public libraries situated across the vast expanse of rural Nebraska.

In Chief Justice Heavican's recent State of the Judiciary Address, he asserted that "one of the most significant challenges confronting our courts is the growing number of untrained, self-represented litigants in civil cases. The growing trend of self-representation presents a challenge for judges and court staff alike." Data from 2003-2008 show an increasing trend of self-represented litigants in Nebraska courts. For example, in county courts during 2008, the number of civil cases filed compared to the number of litigants without attorneys shows an astounding picture: self represented litigants appeared in 123% to 199% of the cases. This means that for each civil case filed, there was always at least one self represented litigant, and often, both parties were not represented by lawyers. The Nebraska Supreme Court's Committee on Self-Represented Litigants has made inroads on this challenge. Over the past three years, significant efforts by volunteer lawyers, judges, and court staff have resulted in (1) providing electronic access to the Judicial Branch for persons to pay fines, file case information, and access court case materials and (2) providing an array of Nebraska-specific legal forms and information for self represented litigants on the Judicial Branch website on such legal issues as divorce, name change, small claims, garnishment, contempt of visitation and child support. However, in our very rural and geographically large state, there is a significant gap in technology, broadband capacity, and local access to this legal and court-based information. Public courthouses do not have the resources or the current capacity to offer the general public access to web-based legal information.

The Nebraska Judicial Branch is committed to work with the Nebraska Library Commission to address this problem of gap in technology, broadband capacity and local access to legal and court-based information. The opportunity to collaborate on the National Telecommunications and Information Administration's initiative to address the technology and broadband connectivity gaps existing across our Mr. Rod Wagner March 5, 2010 Page 2

very rural state through the vehicle of local public libraries is exciting, promising, and will meet a significant need. Public libraries are often more accessible to rural citizens than courthouses – in their locations, their less formal and more welcoming format, and in their mission in providing access to a wide array of general and specific information and resources. The Judicial Branch will work with the Nebraska Library Commission to coordinate its web-based legal and court information with the Commission's website and local libraries' websites. It will assist in expanding the concept of "virtual" legal self-help centers and "e-government" which will be accessible in the local public libraries through increased numbers of public access computers and the all-important upgraded broadband connectivity. It will commit to periodically visiting participating libraries, encouraging local partnerships between the county court staff and the local libraries.

The Judicial Branch cannot emphasize enough the critical nature of the need for NTIA's resources to enhance broadband connectivity and computer access for Nebraska's rural citizens who are, as stated above, increasingly representing themselves in court cases and attempting to access justice resources through the internet. As in the early and mid parts of the twentieth century when rural electrification was last to become a reality in Nebraska and other mid and western rural states, broadband connectivity, and the lack thereof, is a similar reality in this 77,358 square mile state. The potential good and increased access to justice for self-represented litigants and Nebraska's citizens that will result from this partnership with the Nebraska Library Commission is phenomenal.

The Nebraska Judicial Branch appreciates the Nebraska Library Commission's submission and the National Telecommunications and Information Administration's consideration of this application.

We are pleased to write this letter in support of the Nebraska Library Commission's Public Computing Center application for the Broadband Technology Opportunities Program to enhance public computer and Internet access in selected libraries throughout the state. The focus of increasing service to vulnerable populations, including rural populations, matches the work of the National Network of Libraries of Medicine MidContinental Region (NN/LM MCR). The NN/LM is the outreach arm of the National Library of Medicine, and the MidContinental Region encompasses the states of Colorado, Kansas, Missouri, Nebraska, Utah and Wyoming.

According to the Pew Internet Report "The Social Life of Health Information", 61% of American adults are looking online for health information. In partnering with the Nebraska Library Commission, we seek two outcomes that can help provide better access to health information in Nebraska. First, by improving access to broadband through libraries, more citizens in the state (those vulnerable populations without Internet access in their homes) will be able to use their libraries to search for health information online. Secondly, and just as important, the NN/LM MCR will provide training to library staff through this initiative so they can assist their community in locating reliable and trustworthy online resources. It is the intersection of those two objectives that make this proposal particularly attractive for the NN/LM MCR.

Programming topics, which currently include consumer health, emergency preparedness, senior health issues, diversity topics, local health information, and technology topics, will be provided in areas that have experienced geographic barriers. The NN/LM MCR has been using distance learning and communication tools for several years, and is experienced in delivery of distance education. Increased broadband access in these libraries will allow us an additional method beyond traditional face to face teaching to reach rural communities.

Membership in the NN/LM is encouraged in public libraries because they share health information with the public. The benefit to the libraries in becoming members is access to promotional materials, the ability to apply for funding for health information programming, and support from medical librarians in our six state region. Currently, in Nebraska, only 21 public libraries are affiliate members of the NN/LM MCR. This partnership will provide the opportunity to increase the number of members, thus building a stronger network of informed librarians and a more empowered population in the state.

The National Network of Libraries of Medicine, MidContinental Region appreciates the Nebraska Library Commission's submission and the National Telecommunications and Information Administration's consideration of this application.

Yet, we each serve rural communities which the local access to higher education is just not feasible or possible in a face-to-face setting. Therefore the importance of the local library and the local access to the internet and the use of technology are critical.

In the current economy, families are making choices, which might mean their technology access cannot be continued in the home due to cost. But yet the need for additional education and training is now more important than ever to retain or gain employment. All of which again creates that greater need for the local access of computer technology through the local library.

The community colleges continue to strive to increase the course offerings available via the internet to meet the needs of students in rural areas. This program would significantly help in bringing that education to those rural areas throughout the state of Nebraska.

We would hope that the National Telecommunication and Information Administration would give serious consideration to this application by the Nebraska Library Commission.

The McGoogan Library of Medicine is happy to support the Nebraska Library Commission's application for a Broadband Technology Opportunities Program grant. We see the grant as a great opportunity to further serve the health information needs of Nebraskans and continue our long-standing partnership with the Commission and public libraries across the state. We are so glad you decided to apply.

Since 1998, the McGoogan Library has received over 3,700 requests from across Nebraska for consumer health information. Our statistics show great disparities in access with only 10% of these coming from the area west of Grand Island. Counties in the Panhandle Regional Library System are particularly underserved.

Enhanced broadband service to public libraries in Nebraska's central and western rural counties will provide a means to address this disparity. We plan to work with the Nebraska Regional Library Systems, particularly the Meridian, Republican Valley, and Panhandle systems, to raise health information awareness among public librarians, to work with them and their community members, and to remind them the McGoogan Library is available to help with really complex questions. We also plan to raise awareness among human service providers in the same areas, pointing them to resources available through the Internet and their local public libraries. Site visits are planned, along with paid newspaper advertising, which has proven effective in our experience.

Why make the effort? In addition to positive feedback from users across the state, a 2005 study by the Nebraska Task Force on Rural Economic Development (LR 105) cited health information services delivered through the McGoogan Library and its partners as promoting rural economic development in the state. Whereas patient families may pay up to \$500 for a free-lance information search in other areas of the country, self-service and expert information services are available at no cost in Nebraska. The challenge is to get the word out and provide the support needed to effectively use them. Enhanced Nebraska broadband service is an essential part of the infrastructure required to deliver this vital content. We look forward to hearing the Commission's BTOP application has been successful and to working with you.
