EXECUTIVE ORDER NO. 2008-011

CLARIFYING THE CONSOLIDATION OF AGENCY INFORMATION TECHNOLOGY OPERATIONS AND GOVERNANCE UNDER THE DEPARTMENT OF INFORMATION AND TECHNOLOGY

WHEREAS, it is a priority of the State of New Mexico to better serve its citizens by effectively addressing New Mexico's critical technology infrastructure needs;

WHEREAS, support for all State agency information technology ("IT") programs must be improved, the State of New Mexico data must be more effectively secured, systemic infrastructure risks must be mitigated, and utilization and control over IT assets and their costs must be provided;

WHEREAS, the duplication of technology services must be reduced and eliminated and IT investments must be managed effectively and efficiently;

WHEREAS, the cost of government operations can be reduced through effective development, implementation and management of IT architecture, programs and services, IT operational costs can be reduced through enterprise models, and the efficient delivery of high quality government services will benefit clients and support economic development; and

WHEREAS, the Department of Information Technology was created as the single, unified, executive department with authority to consolidate enterprise information technology services duplicated within executive agencies, to provide additional information technology services and functionality, and to improve and streamline the executive branch's information technology systems as provided in the Department of Information Technology Act ("Act"), NMSA 1978, Section 9-27-1 et seq. (2007).

NOW THEREFORE, I, Bill Richardson, Governor Bill Richardson, Governor of the State of New Mexico, by virtue of the authority vested in me by the Constitution and the Laws of the State of New Mexico, do hereby order as follows:


1. As the single, unified executive branch department for information services and technology, the Department of Information Technology shall continue to consolidate all enterprise information technology services and IT functionality within executive agencies as deemed appropriate under the Act.

2. The Department of Information Technology is designated as the single, unified executive branch department with IT consolidation authority to act as the State's enterprise infrastructure services provider, including telecommunications.
3. Chief Information Officers (CIO's) or IT leads (i.e. top ranking IT person) of cabinet and executive agencies will report directly to the office of the secretary or director of their agency. Any exception must be approved by the Governor's Chief of Staff or his designee.
4. All IT staff and IT functions within cabinet and executive agencies will report to the agency CIO or IT lead of that agency. Any exception must be approved by the Governor's Chief of Staff or his designee.
5. The agency CIO or IT lead shall have control and management of all IT expenses within the agency, either by establishment of an independent IT organizational budget or by the establishment of administrative financial controls of IT expenses within existing agency budgets, subject to the approval of the cabinet secretary and the review and approval of the Department of Information Technology, as appropriate under the Department of Information Technology Act..
6. The agency CIO or IT lead will have approval authority over all agency IT-related spending, subject to the approval of the cabinet secretary and the review and approval of the Department of Information Technology, as appropriate under the Department of Information Technology Act.
7. The agency CIO or IT lead will provide quarterly reports of the total number of IT Full Time Equivalent (FTE) employees, part-time employees, temporary hires, consultants on contract, and budget performance to the Department of Information Technology, beginning no later than November 1, 2008;
8. The agency CIO or IT lead will submit a complete inventory of agency IT hardware, software and licenses in a standardized electronic format to be provided by the Department of Information Technology, no later than September 1 of each year.
9. The Department of Information Technology shall create a streamlined exception process for agencies to purchase select IT equipment software and services and hiring IT infrastructure positions by agencies deemed to be mission-critical and which falls outside of an agency's IT Plan. This exception process will be in compliance with the requirements of the New Mexico Procurement Code, the Department of Information Technology Act, NMSA 1978, § 9-27-1 et seq., Department of Finance and Administration regulations, and all other state laws and regulations regarding personnel and equipment. The Secretary of the Department of Information Technology shall approve all exceptions.

I FURTHER DIRECT that all reference to the state Chief Information Officer in past Executive Orders, including Executive Order 2004-004, Establishing the New Mexico Office of Workforce Training and Development, Executive Order 2005-027, Directing State Agencies to Take Specific Actions to Protect Sensitive Information Against Identity Theft, and Executive Order 2007-006, Establishment of the State E911 Coordinating Committee, shall now be considered to refer to the Secretary of the Department of Information and Technology.


THIS ORDER rescinds Executive Order 2003-014, Executive Order 2003-018, and Executive Order 2004-014, and supersedes any other previous orders, proclamation, or directives in conflict. This Executive Order shall take effect immediately and shall remain in effect until such time as it is rescinded by the Governor.

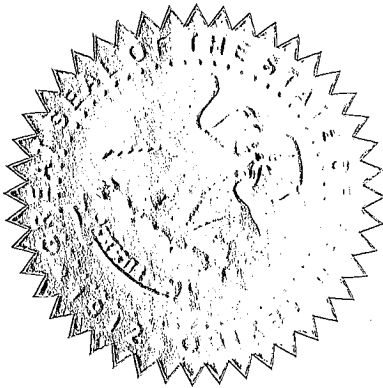

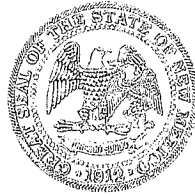

EXECUTIVE ORDER 2009-013

ORDER CREATING THE NEW MEXICO OFFICE OF RECOVERY AND REINVESTMENT; ESTABLISHING A COMPETITIVE GRANT ADVISORY TEAM; AND REQUIRING COOPERATION AMONG STATE AGENCIES

WHEREAS, on February 17, 2009, President Obama signed the American Recovery and Reinvestment Act ("ARRA") into law to counteract the dramatic downturn in the national economy, a downturn that has significantly impacted many New Mexicans;

WHEREAS, as a result of the passage of ARRA, New Mexico must endeavor to take all appropriate steps to maximize its ability to qualify for and receive approximately \$2 billion dollars in federal funds to build infrastructure, stabilize unemployment and healthcare benefits for those in need, avoid deep cuts in the State's education spending, invest in healthcare, and create and retain jobs;

WHEREAS, New Mexico will have an unprecedented opportunity to compete for hundreds of millions of dollars to transform our broadband capability, modernize our energy grid to introduce clean energy into thousands of homes, develop an electronic medical records system that will transform healthcare, and create stable, high-wage jobs in the technology and renewable energy sectors;

WHEREAS, the State must make certain that federal funding is distributed as fairly and evenly as practicable, particularly in rural communities that have been hit particularly hard by the recession;

WHEREAS, New Mexico must leverage and utilize all available resources, including those in the public and private sectors to ensure that the State is well positioned to compete for every available dollar;

WHEREAS, the President and Congress have made clear that it is the responsibility of state governors to ensure that ARRA money is spent appropriately and transparently, and that systems are put in place to track and monitor every dollar spent, with the ultimate goal of creating and retaining jobs; and

WHEREAS, the State must act swiftly to implement ARRA to preserve the health, safety and welfare of the citizens of New Mexico.

NOW THEREFORE, I, Bill Richardson, Governor of the State of New Mexico, by virtue of the authority vested in me by the Constitution and the laws of the State of New Mexico, do hereby order the following:

1. I hereby establish the New Mexico Office of Recovery and Reinvestment ("NMORR"), which shall be responsible for directing and monitoring the implementation of the programs enacted by ARRA. The NMORR's principle functions shall be to ensure that (a) ARRA monies are spent quickly to provide immediate relief to impacted individuals and families and to help stimulate New Mexico's economy as quickly as feasible; (b) that the funding process is fair, merit-based, and transparent to the public; (c) that fraud, waste and abuse is avoided; (d) that state agencies are held strictly accountable for ARRA funds; and (e) as directed by President Obama, that New Mexico's expenditure of federal funds spurs immediate economic activity, creates and retains jobs, and promotes long-term economic prosperity and quality of life by investing in health and science, transportation, renewable energy and other infrastructure that will foster energy independence and improve the quality of the education and healthcare systems in New Mexico.

2. The NMORR shall be staffed as determined by the Governor and shall initially be chaired by former Governor Toney Anaya.

3. The NMORR shall review and make recommendations to the administration regarding the approval of ARRA funding.

4. The NMORR shall create and implement an effective communications and outreach plan, including a State website and such other available technology tools, that shall keep the public informed of the State's ARRA related activities, funding opportunities and the process for applying, and the funding decisions made by the administration.

5. The NMORR shall strive to ensure that all pertinent information is made available to the public regarding possible opportunities for funding and that input to the NMORR is used to maximize the ability of entities within the state to receive funding.


6. In cooperation with the Department of Finance and Administration, the NMORR shall provide a system for tracking, monitoring and auditing the expenditure of ARRA funding, including formula monies, infrastructure projects, and competitive grant monies obtained by the State. To the extent practical, the NMORR shall seek to identify, compile and report to the Governor the total dollars received by non-state government entities in New Mexico.

7. I hereby establish a Competitive Grant Advisory Team ("Team"), which shall be comprised of individuals in the public and private sectors, and which shall (a) work at the direction of the NMORR to assist with outreach and educational efforts throughout the State; (b) leverage all available resources to compete for and obtain competitive ARRA funding; and (c) provide such advice as the NMORR may request in carrying out its responsibilities. Members of the Team, including a chair, shall be appointed by the Governor and shall serve until May 31, 2009. The Team shall be staffed by the NMORR. The Team shall report to the Governor and the NMORR as necessary and as directed. The work of the Team shall be advisory only and

members of the Team shall not receive per diem, pay nor be reimbursed for travel or subsistence expenses, unless otherwise provided by law.

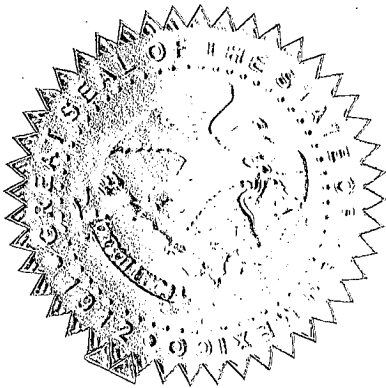
8. State agencies shall work cooperatively with the NMORR to provide any and all information related to the effective and efficient implementation of ARRA funding and programs and shall assist the NMORR with public outreach efforts.

EXECUTIVE ORDER 2009-037

ESTABLISHING THE TRIBAL ECONOMIC DEVELOPMENT TASK FORCE

WHEREAS, the most recent United States Census data shows that 36.2% of Native Americans in New Mexico live below the federal rate of poverty;

WHEREAS, the median income of Native American families is amongst the lowest in the State of New Mexico;

WHEREAS, development of Tribal economies will result in an increase in the types of jobs available in tribal, local and regional economies, and will benefit the economic livelihood of residents of the region;

WHEREAS, other states have created Native American Enterprise Zones as an effective means of attracting business to tribal communities. Such Zones can be established on tribal land through the exercise of state-tribal collaboration and the exercise of sovereign authority;

WHEREAS, the State of New Mexico is pursuing several initiatives in the renewable energy, information technology, tourism, film, and other industries where tribes have interest, resources and capability to participate and thereby enhance the state-wide benefit;

WHEREAS, by supporting greater tribal economic development that is consistent with the sovereignty and cultural traditions of the tribes, nations and pueblos, the State of New Mexico can improve the quality of life of our Native American citizens, decrease high rates of poverty, and bring economic benefit to rural and other areas of our state.

NOW THEREFORE, I, Bill Richardson, Governor of the State of New Mexico, by virtue of the authority vested in me by the Constitution and the Laws of the State of New Mexico, do hereby create the Tribal Economic Development Task Force ("Task Force"), as follows:

1. The duties of the Task Force shall be:
 - a. To research Native American Enterprise Zones and determine if such Zones could be beneficial in New Mexico. The Task Force shall also examine current and potential incentive options to bring high wage jobs to Indian Country, including the development of Gross Receipt Tax incentives;

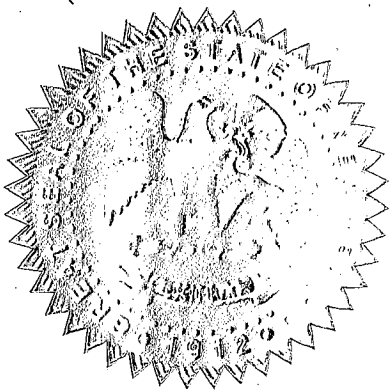
- b. To identify ways for the state to include tribes, nations and pueblos in the development of tourism and tourism resources, including eco-tourism, initiatives, so there is mutual benefit; and
 - c. To identify state resources available to assist tribes in accessing film industry economic development opportunities.
- 2. The Governor shall appoint the membership of the Task Force as follows:
 - a. A co-chair shall be a tribal leader with expertise in tribal economic development;
 - b. A co-chair shall be the Cabinet Secretary of the New Mexico Economic Development Department;
 - c. One member shall be the Cabinet Secretary of the Indian Affairs Department, or designee;
 - d. One member shall be the Cabinet Secretary of the Tourism Department, or designee
 - e. One member shall be the Executive Director of the New Mexico Finance Authority, or designee;
 - f. One member shall be a person with experience with economic development or administration who is a member of a New Mexico Pueblo;
 - g. One member shall be a person with experience with economic development or administration who is a member of the Jicarilla Apache Nation or the Mescalero Apache Tribe;
 - h. One member shall be a person experience with economic development or administration who is a member of the Navajo Nation
 - i. One member shall be a representative of the private business community;
 - j. One member shall be a representative from a New Mexico institution of higher education with a background and specialization in Native American community economic development.
- 3. Appointed members of the Task Force serve at the pleasure of the Governor.
- 4. The New Mexico Indian Affairs Department shall provide administrative staff and support to the Task Force.
- 5. The term of each member shall be from the date of appointment until twenty (20) days after the adjournment of the next regular session of the Legislature, unless otherwise determined by the Governor.
- 6. The Task Force shall convene at least four times, but may convene as frequently as necessary to accomplish the objectives of the Task Force.
- 7. The Task Force shall consult with public and private individuals, experts, and other entities as deemed necessary for the development of its recommendations, and shall consider input from the general public in the development of any recommendation.

8. The Task Force shall prepare and present recommendations for the Governor's consideration no later than November 30, 2009.
9. The Task Force shall act as an advisory body that makes recommendations to the Governor and in no event shall it make final decisions regarding policy.
10. Task Force members shall serve voluntarily and shall receive no pay for their services, nor shall they be reimbursed for travel or subsistence expenses, unless otherwise provided by law.

THIS ORDER supersedes any other previous orders, proclamations, or directives in conflict. This Executive Order shall take effect immediately and shall remain in effect until such time as it is rescinded by the Governor.





TERMS AND CONDITIONS UNLESS OTHERWISE SPECIFIED

1. **General:** When the State Purchasing Agent issues a purchase document in response to the Vendor's bid, a binding contract is created.
2. **Variation in Quantity:** No variation in the quantity of any item called for by this order will be accepted unless such variations have been caused by conditions of loading, shipping, packing or allowances in manufacturing process and then only to the extent, if any, specified in this order.
3. **Assignment:**
 - A. Neither the order, nor any interest therein, nor any claim there under, shall be assigned or transferred by the Vendor, except as set forth in subparagraph 3B or as expressly authorized in writing by the state purchasing agent's office. No such assignment or transfer shall relieve the Vendor from the obligations and liabilities under this order.
 - B. Vendor agrees that any and all claims for overcharge resulting from antitrust Violations which are borne by the State as to goods, services, and materials Purchased in connection with this bid are hereby assigned to the State.
4. **State Furnished Property:** State furnished property shall be returned to the State upon request in the same condition as received except for ordinary wear, tear and modifications ordered hereunder.
5. **Discounts:** Prompt payment discounts will not be considered in computing the low bid. Discounts for payment within 20 days will be considered after the award of the contract. Discounted time will be computed from the date of receipt of the merchandise invoice, whichever is later.
6. **Inspection:** Final inspection and acceptance will be made at the destination. Supplies rejected at the destination for non-conformance with specifications shall be removed at the Vendor's risk and expense, promptly after notice of rejection.
7. **Inspection of Plant:** The State Purchasing Agent may inspect, at any reasonable time, the part of the contractor's, or any subcontractor's plant or place of business, which is related to the performance of this contract.
8. **Commercial Warranty:** The Vendor agrees that the supplies or services furnished under this order shall be covered by the most favorable commercial warranties the vendor gives for such to any customer for such supplies or services, and that the rights remedies provided herein shall extend to the State and are in addition to and do not limit any rights afforded to the State by any other clause of this order. Vendor agrees not to disclaim warranties of fitness for a particular purpose of Merchantability.
9. **Taxes:** The unit price shall exclude all State taxes.
10. **Packing, Shipping and invoicing:**
 - A. The State's purchasing document number and the Vendor's name, user's name and location shall be shown on each packing and delivery ticket, package, bill of lading and other correspondence in connection with the shipments. The user's count will be accepted by the Vendor as final and conclusive on all shipment not accompanied by a packing ticket.
 - B. The Vendor's invoice shall be submitted in triplicate, duly certified and shall contain the following information: order number, description of supplies or services, quantities, unit price and extended totals. Separate invoices shall be rendered for each and every complete shipment.
 - C. Invoices must be submitted to the using agency and NOT THE STATE PURCHASING AGENT.

11. **Default:** The State reserves the right to cancel all or any part of this order without cost to the State, if the Vendor fails to meet the provisions of this order and, except as otherwise provided herein, to hold the Vendor liable for any excess cost occasioned by the State due to the Vendor's default. The Vendor shall not be liable for any excess costs if failure to perform the order arises out of causes beyond the control and without the fault or negligence of the Vendor, such causes include, but are not restricted to acts of God or the public enemy, acts of the State or Federal Government, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, unusually severe weather and defaults of subcontractors due to any of the above, unless the State shall determine that the supplies or services to be furnished by the subcontractor were obtainable from other sources in sufficient time to permit the vendor to meet the required delivery scheduled. The rights of the State provided in this paragraph shall not be exclusive and are in addition to any other rights now being provided by law or under this order.
12. **Non-Collusion:** In signing this bid, the Vendor certifies he/she has not either directly or indirectly, entered into action in restraint of free competitive bidding in connection with this offer submitted to the State Purchasing Agent.
13. **Non-discrimination:** Vendor doing business with the State of New Mexico must be in compliance with the Federal Civil Rights Act of 1964 and Title VII of the Act (Rev.,1979) and the Americans with Disabilities Act of 1990 (Public Law 101-336).
14. **The Procurement Code:** Sections 13-1-28 through 13-1-99 NMSA 1978, imposes civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for bribes, gratuities and kickbacks.
15. All bid items are to be NEW and of most current production, unless otherwise specified.
16. **Payment for purchases:** Except as otherwise agreed to: late payment charges maybe assessed against the user state agency in the amount and under the conditions set forth in section 13-14158 NMSA 1978.
17. **Workers' Compensation:** The Contractor agrees to comply with state laws and tales pertaining to workers' compensation benefits for its employees. If the Contractor fails to comply with Workers' Compensation Act and applicable tales when required to do so, this (Agreement) may be terminated by the contracting agency.

December 24, 2007

I. SCOPE

This implementation guidance applies to Executive Order 2007-049 (hereafter "the Executive Order") and applies to all Invitation to Bid (ITB) and Request for Proposal (RFP) based procurements conducted by Executive Branch Agencies for which the ITB or RFP is made available to the general public ("solicited"), through any means, after January 1, 2008.

II. DEFINITIONS

The following definitions apply to the language contained in the Executive Order.

"Contract" means any agreement for the procurement of items of tangible personal property, services or construction derived from an ITB or RFP.

"Contractor" means an employer contracting with the State of New Mexico, which employer has, had, or anticipates having six (6) or more employees who worked, are working, or are expected to work an average of at least twenty hours per week over a six-month period, with said six month period being at any time during the year prior to seeking the contract(s) with the State, or any time during the term of the contract(s) with the State;

"Employer" means any for-profit or not-for-profit business, regardless of location, that employs one or more persons that qualify as a "New Mexico Employee". (See below.) Such definition does not include governmental entities.

"Expected Annual Value" means the amount of money that a Contractor can reasonably expect to be paid through the provision of services or goods made pursuant to a contract with the State of New Mexico. Such reasonable expectation shall be based upon, in order of preference, 1) the face value of a contract if such value exists; 2) projections made by the State based on historical data if such data exists; or 3) best estimates made by the State. In the case of a projection or best estimate, the State's projection or best estimate shall be final and accepted by the Contractor.

"Incremental Plan" means the phased in requirements set forth in the Executive Order.

"New Mexico Employee" means any resident of the State of New Mexico, performing the majority of their work within the State of New Mexico, for any employer regardless of the location of the employer's office or offices.

"Offer" means to make available to all New Mexico employees, without unreasonable restriction, enrollment in one or more health coverage plans and to actively seek and encourage participation in order to achieve the goals of the Executive Order. This could include State publicly financed public health coverage programs such as *Insure New Mexico!*

"Solicited and Awarded" means an ITB or RFP was made available to the general public, through any means, after January 1, 2008 AND the contract(s) sought as a result of that solicitation was/were awarded after January 1, 2008.

"Solicitations" means ITBs and RFPs.

III. SOLICITATION REQUIREMENTS

All Invitations to Bid and Requests for Proposals made available to the public through any means after January 1, 2008 must contain the following language:

1. For all contracts solicited and awarded on or after January 1, 2008: If the offeror has, or grows to, six (6) or more employees who work, or who are expected to work, an average of at least 20 hours per week over a six (6) month period during the term of the contract, offeror must agree to:

(a) have in place, and agree to maintain for the term of the contract, health insurance for those employees and offer that health insurance to those employees no later than July 1, 2008 if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed one million dollars or;

(b) have in place, and agree to maintain for the term of the contract, health insurance for those employees and offer that health insurance to those employees no later than July 1, 2009 if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed \$500,000 dollars or

(c) have in place, and agree to maintain for the term of the contract, health insurance for those employees and offer that health insurance to those employees no later than July 1, 2010 if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed \$250,000 dollars.

2. Offeror must agree to maintain a record of the number of employees who have (a) accepted health insurance; (b) declined health insurance due to other health insurance coverage already in place; or (c) declined health insurance for other reasons. These records are subject to review and audit by a representative of the state.

3. Offeror must agree to advise all employees of the availability of State publicly financed health care coverage programs by providing each employee with, as a minimum, the following web site link to additional information: <http://insurenwnewmexico.state.nm.us/>.

4. For Indefinite Quantity, Indefinite Delivery contracts (price agreements without specific limitations on quantity and providing for an indeterminate number of orders to be placed against it); these requirements shall apply the first day of the second month after the offeror reports combined sales (from state and, if applicable, from local public bodies if from a state price agreement) of \$250,000, \$500,000 or \$1,000,000.

5. For Indefinite Quantity, Indefinite Delivery contracts (price agreements without specific limitations on quantity and providing for an indeterminate number of orders to be placed against it), or any other contract that does not contain a specific face value, the Expected Annual Value shall be established by the State based on either projections made by the State based on historical data if such data exists or best estimates made by the State. In the case of such a projection or best estimate, the State's projection or best estimate shall be final and accepted by the Contractor.

IV. CONTRACT REQUIREMENTS

All contracts awarded as a result of any Invitations to Bid or Requests for Proposals made available to the public through any means after January 1, 2008, and awarded after January 1, 2008, must contain the following language, renumbered as may be appropriate:

"New Mexico Employees Health Coverage"

1. If Contractor has, or grows to, six (6) or more employees who work, or who are expected to work, an average of at least 20 hours per week over a six (6) month period during the term of the contract, Contractor certifies, by signing this agreement, to:

(a) have in place, and agree to maintain for the term of the contract, health insurance for those employees and offer that health insurance to those employees no later than July 1, 2008 if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed one million dollars or;

(b) have in place, and agree to maintain for the term of the contract, health insurance for those employees and offer that health insurance to those employees no later than July 1, 2009 if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed \$500,000 dollars or;

(c) have in place, and agree to maintain for the term of the contract, health insurance for those employees and offer that health insurance to those employees no later than July 1, 2010 if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed \$250,000 dollars.

2. Contractor agrees to maintain a record of the number of employees who have (a) accepted health insurance; (b) declined health insurance due to other health insurance coverage already in place; or (c) declined health insurance for other reasons. These records are subject to review and audit by a representative of the state.
3. Contractor agrees to advise all employees of the availability of State publicly financed health care coverage programs by providing each employee with, as a minimum, the following web site link to additional information: <http://insurenwnewmexico.state.nm.us/>.
4. For Indefinite Quantity, Indefinite Delivery contracts (price agreements without specific limitations on quantity and providing for an indeterminate number of orders to be placed against it); Contractor agrees these requirements shall apply the first day of the second month after the offeror reports combined sales (from state and, if applicable, from local public bodies if from a state price agreement) of \$250,000, \$500,000 or \$1,000,000, depending on the dollar value threshold in effect at that time.
5. For Indefinite Quantity, Indefinite Delivery contracts (price agreements without specific limitations on quantity and providing for an indeterminate number of orders to be placed against it), or any other contract that does not contain a specific face value, the Contractor agrees the State's projection or best estimate shall be final and accepted by the Contractor.

V. EFFECTIVE DATE

This Implementation Guidance shall be effective December 1, 2007.

Under the terms and conditions of this Price Agreement all State of New Mexico Agencies, Commissions, Institutions, Political Sub—divisions and Local Bodies allowed by law may issue orders for items and/or services described herein. The terms and conditions of this Price Agreement shall form a part of each other issued hereunder.

The item and/or services to be ordered shall be as listed under **ARTICLE IX - Price Schedule**. All orders issued hereunder will bear both an order number and this Price Agreement number. **It is understood that no guarantee or warranty is made or implied, by either the New Mexico Agent or the user, that any order for any definite quantity will be issued under this Price Agreement.** The contractor is required to accept the order and furnish the items and/or services in accordance with the articles contained hereunder for the quantity of each order.

ARTICLE II – TERM

The term of this Price Agreement for issuance of orders shall be as indicated in specifications.

ARTICLE III – SPECIFICATIONS

Items and/or services furnished hereunder shall conform to the requirements of specifications and/or drawings applicable to items listed under **ARTICLE IX-Price Schedule**. Orders issued against this schedule will show the applicable Price Agreement item(s), number(s), and price(s); however they may not describe the item(s) fully.

ARTICLE IV – SHIPPING AND BILLING INSTRUCTIONS

Contractor shall ship in accordance with the instructions of this form. **Shipment shall be made only against specific orders which the user may place with the contractor during the term indicated in ARTICLE II-TERM.** The contractor shall enclose a packing list with each shipment listing the order number, Price Agreement number and the commercial parts number (if any) for each item. Delivery shall be made as indicated on page 1. If vendor is unable to meet stated delivery the State Purchasing Agent must be notified.

ARTICLE V – TERMINATION

This Price Agreement may be terminated by either signing party upon written notice to the other at least **thirty (30)** days in advance of the date of termination. Notice of termination of the Price Agreement **SHALL NOT AFFECT ANY OUTSTANDING ORDERS**.

ARTICLE VI – AMENDMENT

This Price Agreement may be amended by mutual agreement of the NM State Purchasing Agent and the contractor upon written notice by either party to the other. An amendment to this price Agreement **SHALL NOT AFFECT ANY OUTSTANDING ORDERS** issued prior to the effective date of the amendment as mutually agreed upon, and as published by the NM State Purchasing Agent. Amendments affecting price adjustments and/or extension of contract expiration are not allowed unless specifically provided in the bid and contract documents.

ARTICLE VII – ISSUANCE OF ORDERS

Only written signed orders are valid under this Price Agreement. Form SPD-001A is approved for state agencies issuing Contract orders under this Price Agreement. Other authorized government entities may utilize Form SPD-001A or forms adapted by them for their own use.

ARTICLE VIII – PACKING (IF APPLICABLE)

Packing shall be in conformance with standard commercial practices.

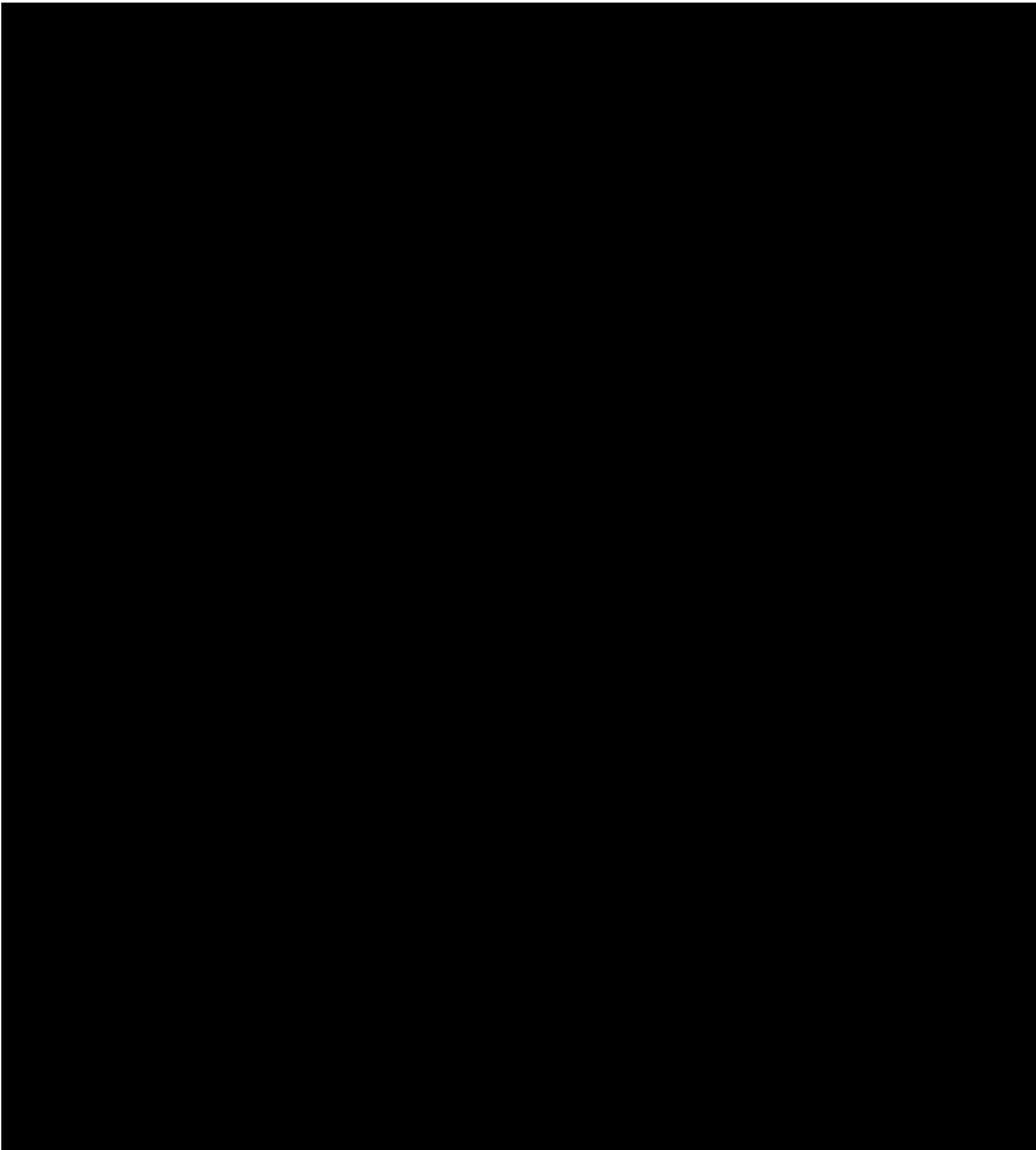

Microwave Radio Network

The Department of Information Technology maintains and operates the State's Broadband Digital Microwave Radio Communication network. The primary purpose of the microwave network is to enable interoperable mobile radio communications for public safety (i.e. State Police, Department of Corrections), other state agencies (i.e. Department of Game and Fish, Department of Transportation), and for various local and federal entities. The microwave network connects dispatch centers throughout the State with a network of radio towers that communicate with State Police vehicles and other mobile units.

The Digital Microwave System supports and interconnects the following two way-radio services:

- Local Base - Provides instantaneous two-way radio communications between a dispatch center and employees working in the immediate area or close proximity. As an example a State Parks Dispatcher at Park headquarters could contact a Park Ranger working on the other side of the Park.
- Remote Base - Provides instantaneous two-way radio communications between a dispatch center and employees working long distances from the center. As an example a State Police Dispatcher could contact an officer on patrol possibly hundreds of miles from the dispatch center.
- Single Channel Console - Provides a convenient, functional, and inexpensive interface between a dispatcher and one local or remote base station.
- Multi Channel Console - Allows a dispatcher to control multiple local and/or remote base stations from a single dispatch center.
- Mobile Radio - Usually installed in a service vehicle, allows employees in the field to communicate to a dispatch center through a local or remote base station.
- Mobile Radio with Repeater - Allows an employee, typically police officers, to operate their mobile radio when they are out of the vehicle. An officer on foot can instantaneously communicate from a hand held radio to a dispatch center hundreds of mile away.
- Radio Pager - A radio pager functions as a hand held radio and can also receive pages from any telephone.
- Portable Radio - Provides communication between a small handheld device and another portable radio in the area or through a base station to a dispatch center.

The Statewide Digital Microwave System also supports broadband data services and telephone to agency field offices:

- T-1 or greater bandwidth connecting isolated field offices to headquarter data networks and Internet services.
- Telephone service to remote stations lacking commercial providers.
- Collocation agreements with cell providers to expand cellular service to rural areas.
- Security alarming and video monitoring of critical State communications facilities.

Additionally, DoIT runs the Santa Fe Control Dispatch Center which was established to provide statewide radio dispatch services to public law enforcement and other state agencies. Its sole purpose is to conduct effective communication that will ensure the safety of the citizens and client employees that it serves. The

State of New Mexico has mandated that it be adequately staffed seven days a week, twenty-four hours a day.

Dispatch operations include monitoring, gathering, processing and disseminating all radio transmissions from field units of all agencies as well as all related incoming and outgoing telephone communications for each agency served.

DoIT funds and manages the Radio Communications Maintenance group including fully equipped repair shops in Santa Fe, Las Vegas, Albuquerque, Roswell and Las Cruces. The Radio Maintenance group provides 24/7 emergency repair services. They install and maintain all the State of New Mexico Digital Microwave Radio Network, Dispatch centers and two-way public safety radio systems.

Customer Responsibilities

- Prospective two-way radio customers should determine what field units, in what areas, need to communicate with what dispatch centers or other field units.
- Digital Microwave telephone customers need to determine how many telephone lines (or fax) are required and where the central office should be.
- Customers interfacing dispatch centers to the Digital Microwave Network need to determine which remote base stations they need to control based on the field units in their area of responsibility.
- Customers must update DoIT with projected needs so equipment purchases and personnel schedules are planned prior to critical need.
- Customers must notify DoIT immediately if their system is not functioning as expected.
- Customers must be available to test and confirm operation of newly installed, upgraded or repaired systems.
- Customers must work with DoIT to maintain an accurate inventory of equipment and services for proper billing and replacement planning.
- DoIT technical and engineering personnel are available to assist customers in planning and determining communications needs.

Service Support

This service is available to customers 24 x 7, excluding planned outages, maintenance windows and unavoidable events. Maintenance windows are used only when needed for scheduled changes.

The Department of Information Technology Enterprise Support Desk operates 24 x 7 and offers a single point of contact for all customer inquiries related to services and the State's technical infrastructure.
