The modifications to the originally approved project would result in 6 new microwave paths totaling 19 miles, 2 improved paths totaling 54 miles and the addition of 5 new CAI's and 1 improved CAI. All are schools within the previously approved area of the 5 county project.

First Step is working with EHP and has hired a consultant to assist with the review of the pending sites.
