Internet2 fully transitioned all of its pre-existing 10G services off its legacy optical system and onto the BTOP-funded Ciena infrastructure in Q4 2012. In addition, Internet2 placed colocation orders for two additional Layer2/Layer3 locations to be installed in Q1 2013 that had been included in the approved application. Internet2 also began logistics planning and pre-deployment activity for the replacement of the legacy Layer3 equipment in Q1 2013. Internet2 received indications of preliminary approval of the Northern Tier portion of the BTOP footprint and began pre-planning discussions with Zayo communications.

In addition, Internet2 plans to have completed logistics planning and pre-deployment tasks for an additional seven Layer2/Layer3 aggregation nodes to be deployed in Q2 2013. Internet2 also expects to replace the majority of its Layer3 routing equipment by the end of March. Assuming NTIA approval of the route change along the Northern Tier, Internet2 and Zayo expect to have a large portion of the optical build between Seattle and Chicago complete.
