The Outside Plant project commenced April 2011 and the contractor has plowed 17.5 miles of conduit from the north end of the Town of Jackson to well inside Grand Teton National Park, completing over 6000' of bores. The contractor has met the Phase I requirement in terms of placing duct to the majority of the Community Anchor Institute properties. A crew is currently working on setting hand-holds, placing equipment, blowing fiber, splicing, testing etc.

It is anticipated that the Outside Plant Project will be 60% complete. Fiber for Phase I will be completed and ready for use by the end of October which will allow up to 15 Community Anchor Institutes to begin receiving services. A crew will begin plowing at the top of Togwotee Pass, working down-hill to tie into the conduit that has been placed to date, thus putting the recipient and project ahead of schedule.

\$393,000 has been budgeted for Land, Structures, ROW and Appraisals, which includes acquisition costs of land for one building and the construction of two buildings in this figure. We anticipate expending funds in this category during q3 2011 and q4 2011. Systems facilities equipment procurement will commence q3 2011 and will be paid in q4 2011.
