This allowed Bluebird to contract with four different construction companies to build the fiber routes mitigating the risk of a single company faltering. Bluebird also went directly to several quipment manufactures to request a bid on the equipment used for this BTOP project. This strategic decision has allowed Bluebird to otain the lowest price for manufactured goods without paying a premium to a re-seller.
