During this quarter, Quarter 3 of 2011, Bloomingdale Communications, Inc. worked on the Construction Request for Proposal (RFP). In the beginning of the quarter, Bloomingdale Communications, Inc. received bids for the construction portion of the project, however all bids received were above budget amounts which seemed to be due to the strict timing of the project. Therefore, Bloomingdale Communications, Inc. decided to reject all initial bids and re-open the RFP process for construction based on a less stringent timeline for the construction portion of the project. This was successful as the new bids received were more in line with the budget of the project, however the construction deadline was moved to October 2012 which will put the project a couple of months behind schedule, however the project overall will still be complete well within the 3 year grant window. Bloomingdale Communications, Inc. will make its official construction vendor selection in the first part of Quarter 4 of 2011.

The coordination with Merit Networks on their Round 1 award also continued this quarter in regards to the joint build approach for the two National Telecommunications and Information Administration awards. This quarter there were meetings with Bloomingdale Communications, Inc. and the City of South Haven to continue discussions of the project.

Bloomingdale Communications, Inc. is still in the process of developing the sub-recipient contracts.

Bloomingdale Communications, Inc. worked on the Rights of Way and Construction permits for this project this quarter and has most of the county road, drain, and soil erosion permits ready. Still working on the state highway and railroad permits, however there is plenty of time since construction will not start till spring of 2012.

Bloomingdale Communications, Inc. still expects the fiber optic cable to be delivered next quarter in November 2011. The single fiber vendor selected in 2nd Quarter of 2011 was Power & Telephone. Vantage Point Solutions, the selected engineering firm, also continued to work with Bloomingdale Communications, Inc in regards to the project.

The number of jobs created or retained in the 3rd Quarter of 2011 was 1.28 full time equivalent. Bloomingdale Communications, Inc. drew down \$44,454.68 in federal funds in the 3rd quarter of 2011.
