1. Please describe significant project accomplishments completed during this quarter (600 words or less).

The cultural survey specialist completed the field survey and submitted a preliminary report. The planned fiber route is viable from this report with no significant findings. The tribe's cultural committee was part of the field survey process, using a tribal monitor for observation. They are also satisfied with the proposed fiber route and will recommend this route in a report for the tribal council. The US Fish & Wildlife Service issued a letter of concurrence for the project. We are reviewing the construction requirements pertaining to that letter. The attorneys for the tribe have made significant progress with the tribe's fiber contracts. The telecommunications company agreed to increase the fiber exchange to four strands for maintenance purposes. They've also agreed to extend the original agreement so that we can meet the 20 year requirement for fiber contracts. This should increase the value of the tribe's in kind match once we have this contract finalized and appraised. A request for quote was sent out and we hired a firm to conduct an appraisal of the fiber agreement. The federal program officer and federal grants specialist came out for a site visit. Agendas and timelines were established to accelerate the completion of the environmental assessment and approval of the construction contract. The tribe's Realty Department has begun review of the easements and right of way agreements on the fiber route. They are also initiating the request for quotes so that we may provide appraisals for the in-kind match documentation of tribal land being donated to the project. We have also hired the project manager for the project. This person will oversee the daily details of the project and reporting and enable the Program Director to focus on the long-term sustainability details.

The primary detractions are the tribe's fiber agreement, the environmental assessment, and the lack of a completed and council approved contract with our vendor / partner so that we can begin the formal engineering designs and the material procurement. Minor details on the fiber agreement are still being worked out by the attorneys so we are very close to completing this agreement. However, the appraiser for the value was brought on board and the appraisal will be completed early in the next quarter. The environmental assessment is the biggest detractor, because the cultural survey work has taken significantly longer than planned. With the help of BTOP after our site visit, we have implemented target dates to remove these obstacles. The cultural survey work and concurrence letter is expected during the next quarter and the construction contract with our vendor will be completed by the middle of the next quarter. We also will have our fiber in-kind match valuation completed early in the quarter. |
| 2b. | Environmental Assessment | 80 | There has been no progress on this because the cultural survey preliminary report was deemed insufficient by the State Historical Preservation Office for their issuance of a letter of concurrence. They are requiring the complete inventory report which will not be completed until the middle of the next quarter. We have made arrangements with the cultural survey specialist to bring in additional help and expedite this report. |
| 2c. | Network Design | 50 | We have not been able to make progress on this. The primary fiber route does appear to be finalized, but without the engineering contracts we can't provide the department of transportation the network designs in the manner they require. We are expediting the contract with the partner vendor to get this done by modifying the shortterm budget and pushing for a mid quarter completion of this contract. |

3. To the extent not covered above, please describe any challenges or issues faced during this past quarter in achieving planned progress against the project milestones listed above. In particular, please identify any areas or issues where technical assistance from the BTOP program may be useful (600 words or less).

The first challenge has been getting the environmental assessment completed. The preliminary report wasn't sufficient for the State Historical Preservation Office to issue a letter of concurrence. They cited section 106 of the Federal Historical Preservation Act requiring a complete inventory of sites that may have eligibility for the federal registry. This report is significant in size, and the completion date isn't expected until well into the next quarter. Also at issue is a late finding in the environmental assessment specifying construction shutdown for a four month period next spring due to bird migration. Because it wasn't specified in the US Fish & Wildlife's letter of concurrence, we are investigating this issue and its impact. Although the tribe's fiber right's negotiations have progressed, they weren't far enough along to complete the appraisal for our in-kind match. This situation did change at the end of the quarter, and this should be rectified. The contract with our contractor has not progressed satisfactorily and so our engineering designs are delayed, and this impacts our right of way approvals from the Nevada State Department of Transportation. The BTOP program stepped in during their site visit at the end of the current quarter and has provided significant help with us in creating aggressive time lines to accomplish these tasks.

Another significant accomplishment we expect to complete is the environmental assessment.

There is still an issue with the environmental assessment regarding a construction blackout from March 31 through August 31 in 2012. With the help of BTOP, we are trying to mitigate this issue by providing for a biologist during construction, if occurring within this time frame. The reason it may become a problem is that it could impact construction costs and BTOP's two-thirds spending requirement by the end of the second year of the grant period. The timeline for completing the contract with our construction partner might prove a little aggressive. The reason is that there are tribal issues around sovereignty and TERO that must be implemented. There is also a

requirement that this contract be approved by the Tribal Council, and they will require sufficient time for review. Our in kind match is temporarily stalled by legal issues regarding the failure of the fiber communications company, which provided the dark fiber in exchange for easements in consideration of traversing tribal lands with their fiber installation, and Nevada Department of Transportation to obtain proper documentation for the easement of their installation. The Bureau of Indian Affairs is requiring the proper recording of the easement includes a survey of the existing route. The appraisal was completed for the tribe's in kind match of the fiber indefeasible right to use and it is appraised at \$2.7 million. The tribe is also in the process of posting request for quotes for the appraisal of the tribe's in kind match of land for the the fiber route and the node sites. This appraisal will probably exceed the current spending level, and the two appraisals will exceed the requisite match requirement.
