Merit also attached the final eight Community Anchor Institutions (CAIs) as part of our BTOP award, and six as part of our sustainability model outside of the BTOP award during this quarter. General monitoring and maintenance of the network is ongoing. Merit has been engaged in preparing documentation for a re-budget request, which is nearing completion.
