In addition, an increase in efforts on the regeneration shelters will occur this quarter with a focus on procurement activities including various RFPs. There is also be a continued efforts on leasing/sales and customer interconnection.

Other key metrics include:

- -Deployment of 7 additional miles bringing to total deployed to 1,150 (which is also the total for the project inclusive of the backbone, the Biddeford extension, and the CAIs).
- -An additional 12 CAI's connected, for a total of 100 out of 100 approved CAIs completed.
