The average site had its bandwidth increased by over 75 times. Almost all community colleges and higher educational institutions went from 1 Gbps to 10Gbps. Almost all K-12 sites went for 6 Mbps to 1Gbps. The increase across all sites were summed and divided by the number of sites to reach the weighted average increase in bandwidth.
