On February 22, 2012, President Barack Obama signed into law the Middle Class Tax Relief and Jobs Initiative of 2012 (HR 3630). In light of this legislation, on April 2, 2012, verbal notification was received from the Department of Commerce (DOC) indicating a freeze on the LA-RICS Authority's ability to spend Broadband Technology Opportunity Program (BTOP) grant funds pending a determination of FirstNet system architecture for the Nationwide Public Safety Broadband Network. Written notice was sent to both proposers on April 4, 2012, informing them of the suspension of negotiations. On May 11, 2012, formal notification was received from the DOC clarifying their April 2nd directive. The suspension was further continued on May 11, 2012, based on the written notification from DOC. The LA-RICS Authority is continuing to work with DOC to clarify what portions of the LTE broadband project may proceed and which portions must remain suspended. At this time, the LA-RICS procurement is still on hold until the LA-RICS Authority determines the best option in moving forward with the procurement process.
