On July 1, 2013, LA-RICS executed a Spectrum Management Lease Agreement with FirstNet. This was followed by the NTIA lifting of the partial suspension on the BTOP award on August 9, 2013.

On the procurement for the LTE system contractor, LA-RICS completed preparation of its RFP #008. The RFP was released on August 13, 2013, followed by a proposers' conference on August 22, 2013. LA-RICS accepted questions from proposers until August 29, 2013 and set the deadline for submitting proposals on October 2, 2013. Preparation for the upcoming proposal evaluation process began with the orientation of subject matter experts.

Drafts of site access agreements were distributed to City Managers relating to respective LTE sites. Initial meetings and language negotiations relating to site access agreements are in progress.

As part of community outreach work, meetings were held with representatives of 30 communities. Presentations were made followed by productive discussions, which gave communities a better understanding of the LA-RICS project.

Environmental assessment, including discussions with the federal environmental team are ongoing.
