REASON(S) FOR AMENDMENT

This request is predicated upon the following information:

Shortly after the grant award, the environmental assessment process, the extent of which had not been anticipated, caused delays of up to six months. During this entire process, the grant was not approved to begin construction of any type. Also, during this period, due largely to Tsunami damage, a major shortage of fiber further delayed the project. To mitigate these delays, NTIA approved purchases of some goods and materials; however, construction could not commence.

As the full impact of construction delay due to environmental and fiber shortages became apparent, Frontier Communications submitted, and NTIA approved, a mitigation plan indicating grant construction completion during December 2012 and January 2013.

This Amendment approved by the Grants Officer is issued in triplicate and constitute an obligation of Federal funding. By signing the three documents, the Recipient agrees to comply with the Amendment provisions checked below and attached, as well as previous provisions incorporated into the Award.
