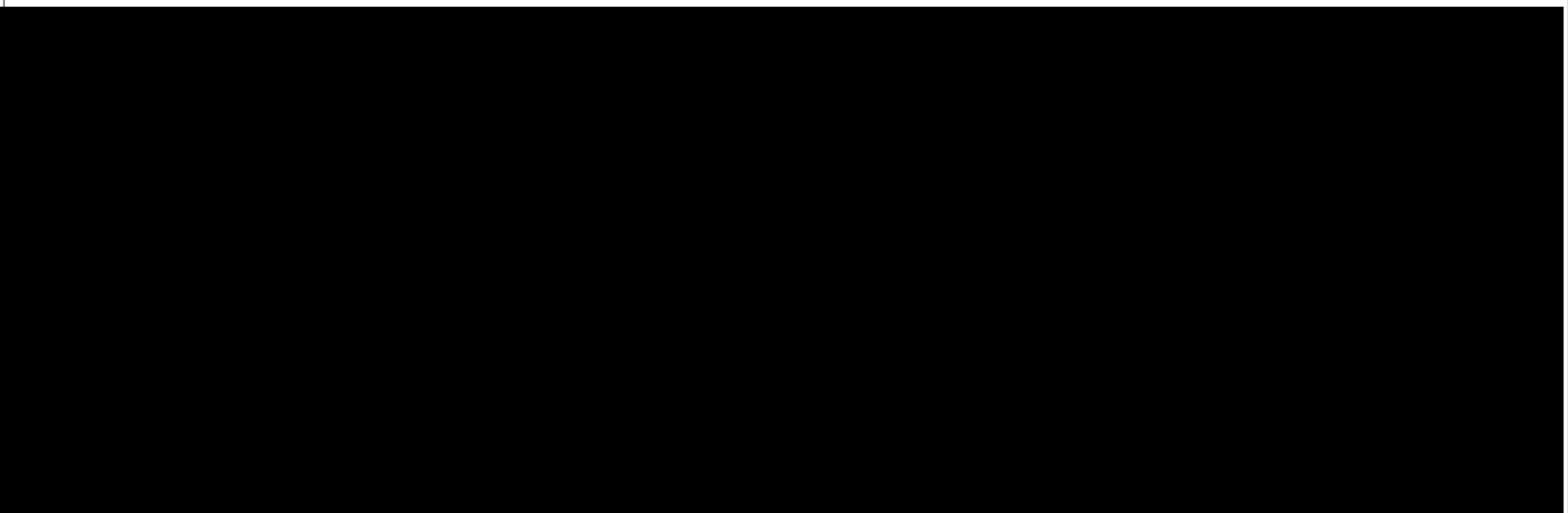

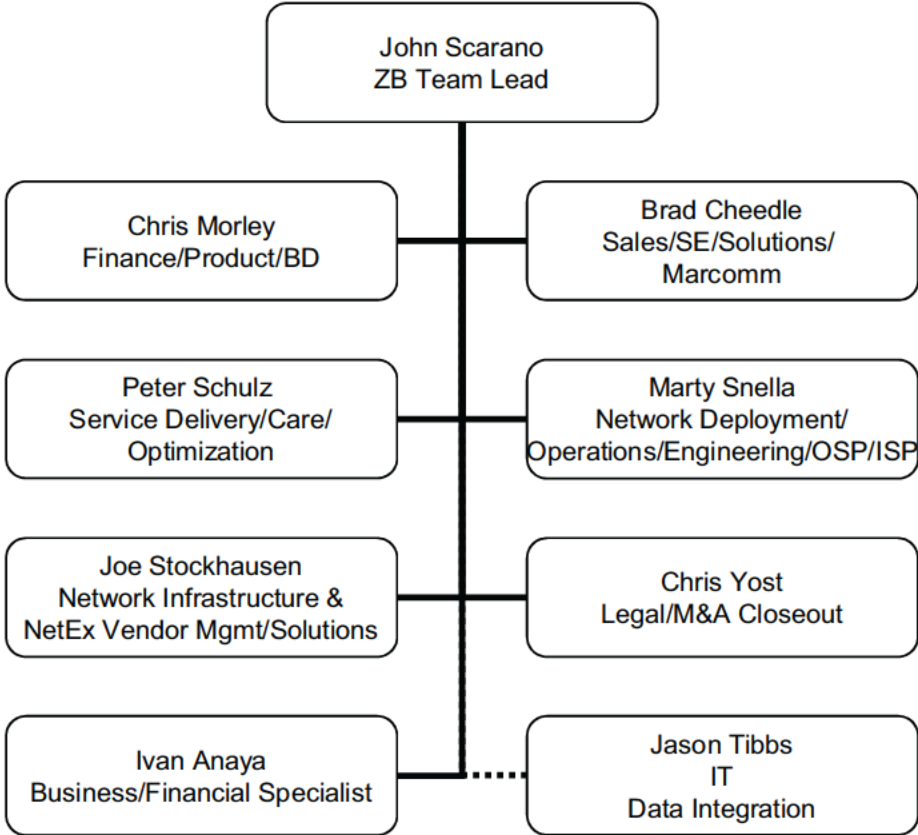

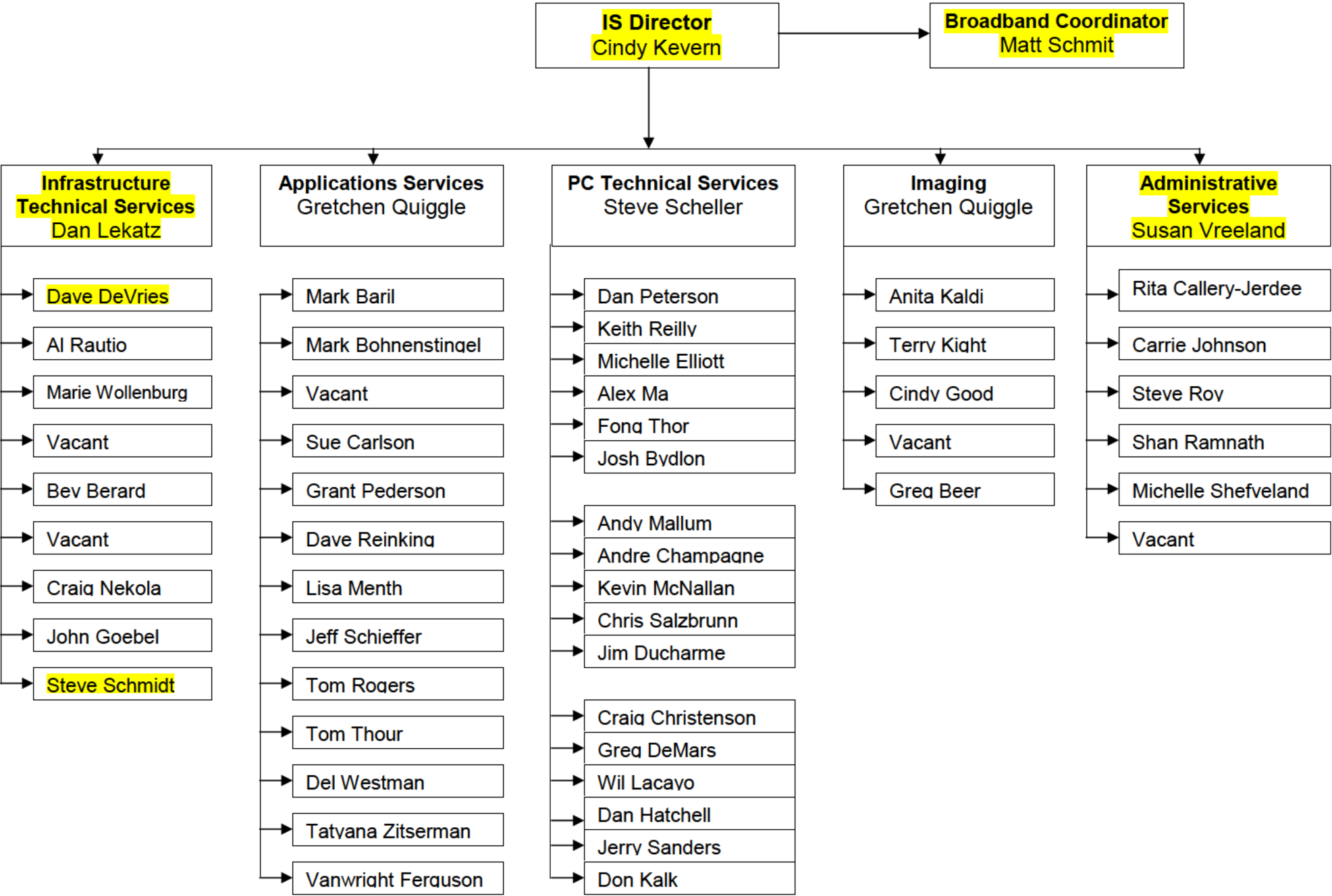

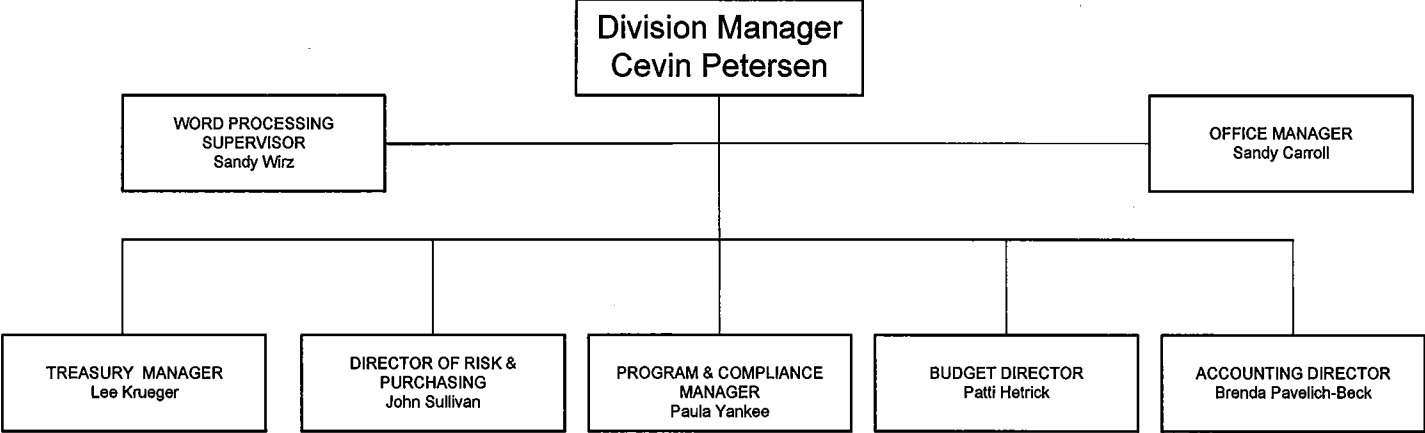




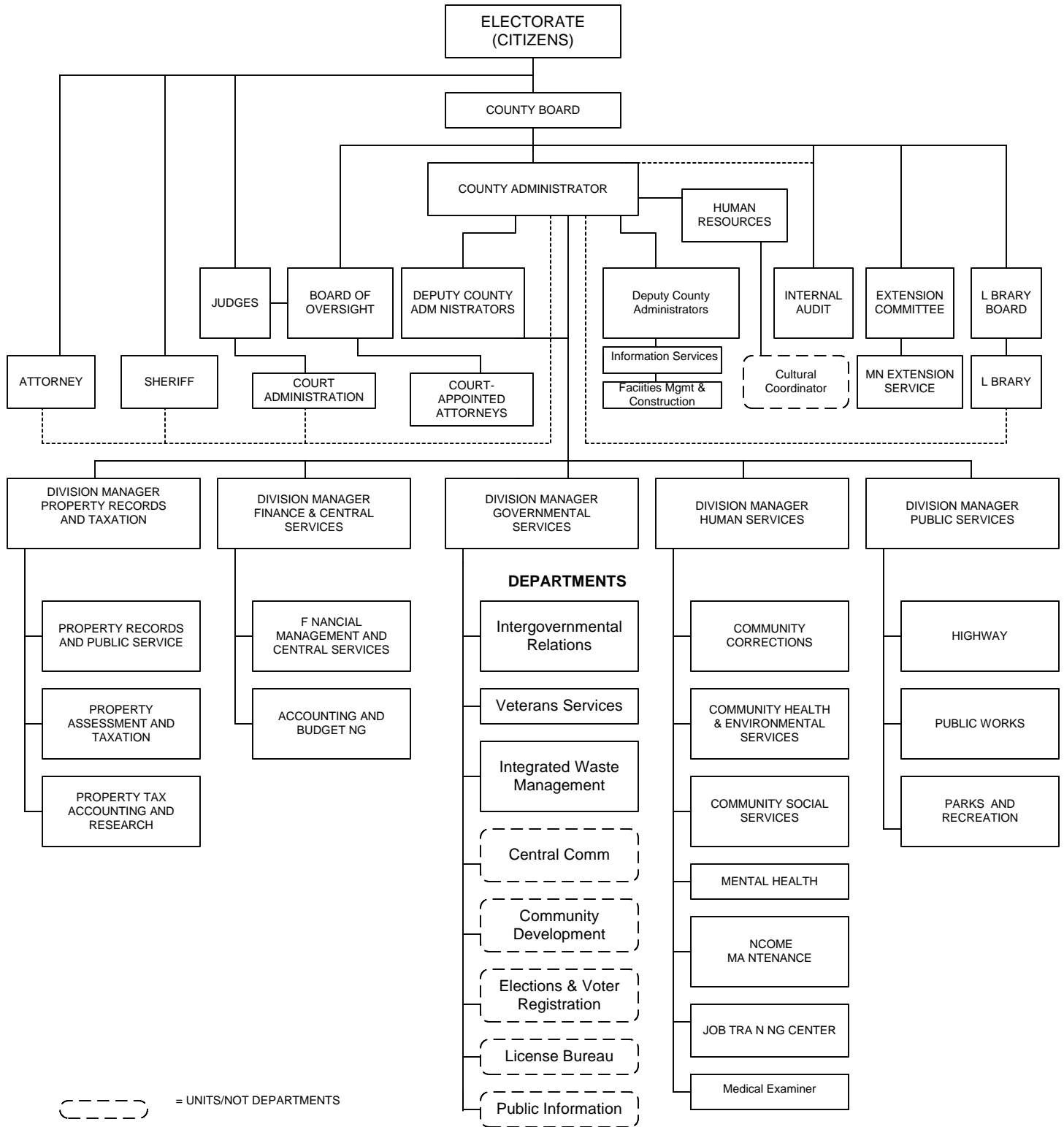
# Anoka County Information Services Organization Chart by Person
